The Department of Environmental Protection is readopting N.J.A.C. 7:14D, Determination of Environmental Benefit of the Reuse of Further Treated Effluent in Industrial Facilities, without change. and review process for the DEBs. An applicant who receives a DEB can file with the Division of Taxation a claim for a corporate business tax credit and/or sales tax refund for qualifying equipment in accordance with N.J.S.A. 54:10A-5.31 and N.J.S.A. 54:32B-8.36.

The notice of proposal was published in the New Jersey Register at 40 N.J.R. 533(a) on January 22, 2008. The public comment period for the proposal closed on March 22, 2008.
