NJDEP is proposing new water quality management planning rules that will reassign wastewater management planning responsibility to the County Freeholders; withdraw and re-designate general wastewater service areas where a WMP is not in compliance with the established schedule; require municipalities to pass an ordinance designed to assure septic maintenance; and require updated WMPs to address septic density in a manner that demonstrates compliance with a 2 mg/L (ppm) nitrate planning target.

Thursday, June 21: 10:00 am to noon

**Place: Gloucester County Government Services Building
1200 Delsea Dr., Clayton, NJ**

From the North: Take Interstate 295 south to the NJ Route 42 Interchange. Go south on Route 42 (toward Atlantic City) to Rte 55 south. Proceed southbound on Rte 55 for 9 miles to Exit 50 for US Route 322 (Glassboro)/Mullica Hill exit). Take the eastbound exit (the second exit) onto Rte 322 east toward Glassboro.

On Rte 322 east, continue past Rowan University until reaching NJ Route 47 (Delsea Drive) in Glassboro. Turn right onto Rte 47 and proceed approximately 3 miles until reaching the Gloucester County Governmental Services Complex on the right-hand side. The meeting is in the large main building.

From the South: Use Route 55 north to Exit 45 for Co. Rte 553 (Clayton exit). At the top of the ramp, turn right (north) onto Rte 553 and then make the very first right onto Silver Lake Rd. Follow the road as it curves and passes Silver Lake on your left. Immediately past the lake, bear left onto Academy Ave. Take Academy Ave. to the light at Delsea Drive (Rte. 47). Turn left (north) onto Delsea. The Gloucester Co. Government Complex is 1.1 miles up on Delsea Dr., on the left-hand side. The meeting is in the large main building.

From East or West: Using Route 40. Take Rte. 40 to its intersection with Route 55. Follow directions From the South, above.

From the West: using Route 322. Take Rte 322 into Glassboro until it intersects with Rte. 47 (Delsea Drive). Follow directions in From the North, above.

**Place: The Conference Center at RWJ Hamilton Center for Health and Wellness

From NJ Turnpike: Take Exit 7A to I-195 West to Exit 60 B (I-295 N), to Exit 65 A, Sloan Avenue. Bear right off the exit. Continue through first light. Make right into Shopping Plaza. The Center is located on the right-hand side.

From New Brunswick: Proceed South on Route 1. Merge onto I-295 South. Take Exit 65 A, Sloan Avenue East. Bear right off the exit. Continue through first light. Make right into Shopping Plaza. The Center is located on the right-hand side.

From Shore: Take I-195 West to Exit 60 B (I-295 N), to Exit 65 A, Sloan Avenue. Bear right off the exit. Continue through first light. Make right into Shopping Plaza. The Center is located on the right-hand side.

From I-295: Take Exit 65 A, Sloan Avenue East. Bear right off the exit. Continue through first light. Make right into Shopping Plaza. The Center is located on the right-hand side.

Monday, July 9: 7:00 pm to 9:00 pm

**Place: Morris County Freeholder's Room
5 Court St, Morristown, NJ 07960**

From the North and NYC: Take I-80 W. to I-287 S. to Exit 36 (Morris Street). Follow Morris Street to the park (Morristown Green), go half-way around & turn right onto Washington Street. The Courthouse & County administration building are two short blocks from the Green on the left. While on Washington Street, make left on Schuyler Place and park in the public parking lot.

From Trenton and Southern NJ: Take I-287 N. to Exit 35 (South Street) make left on South Street (becomes RT. 124). Continue West on South Street to the Park (Morristown green). Go three quarters around the Green and turn right onto Washington Street. The Courthouse and County administration building are two short blocks from the Green on the left. While on Washington Street, make left on Schuyler Place and park in the public lot.
