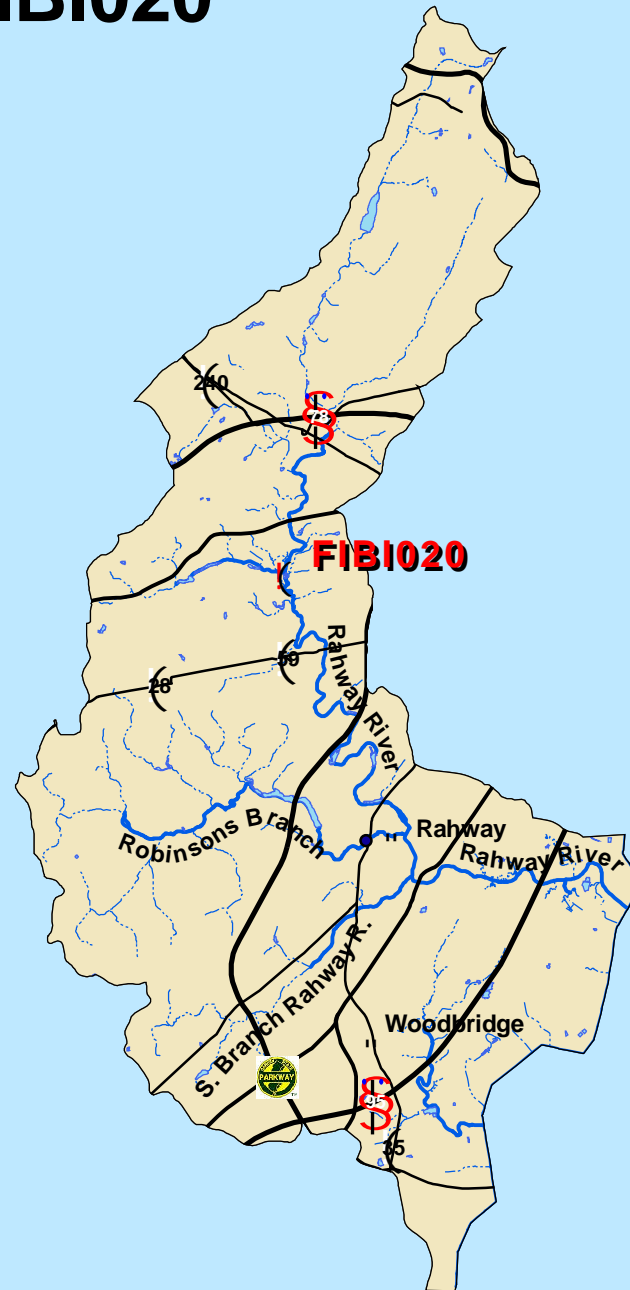

FIBI Sampling Location

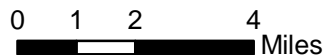
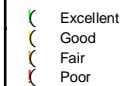


Small Streams (1st and 2nd Order)

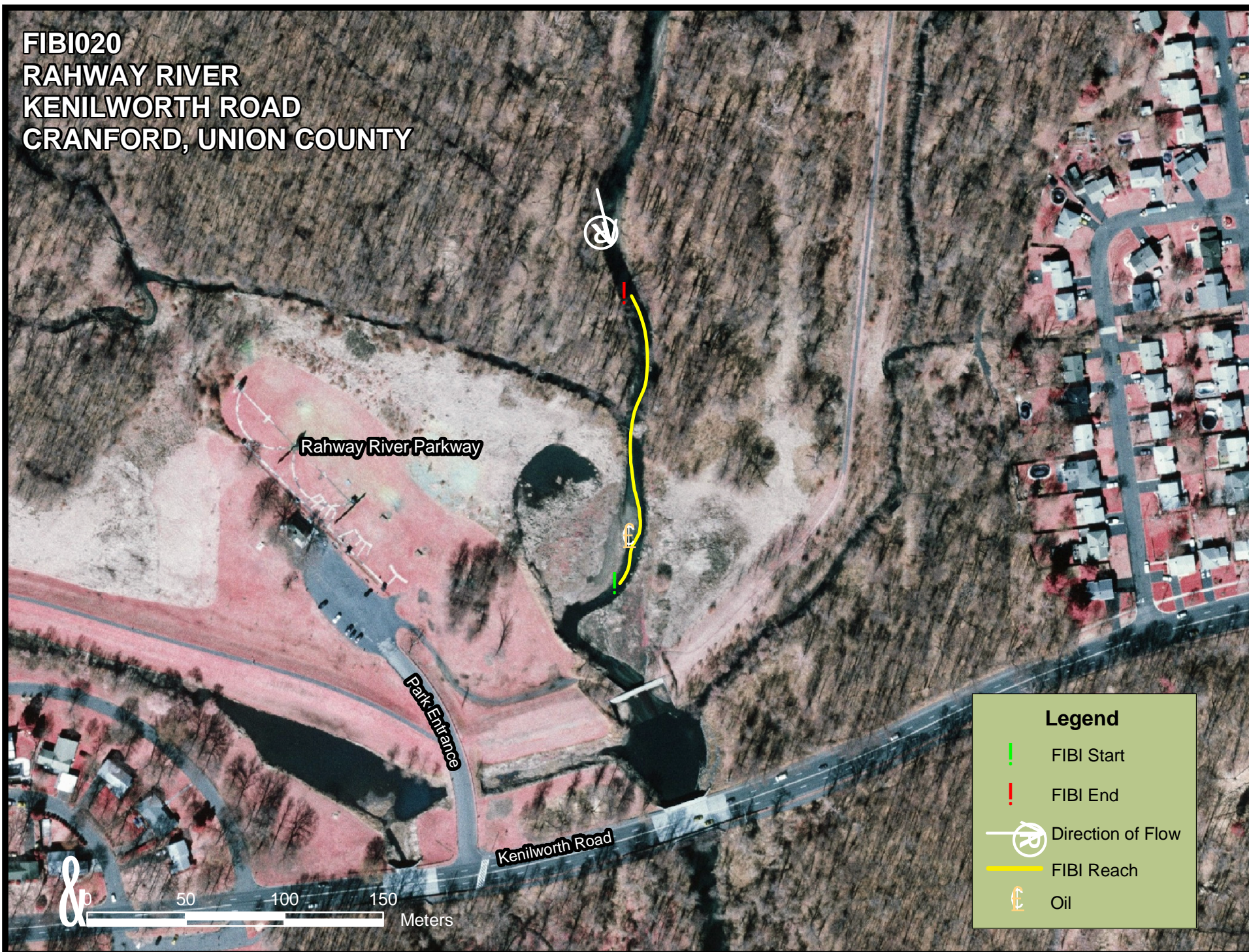

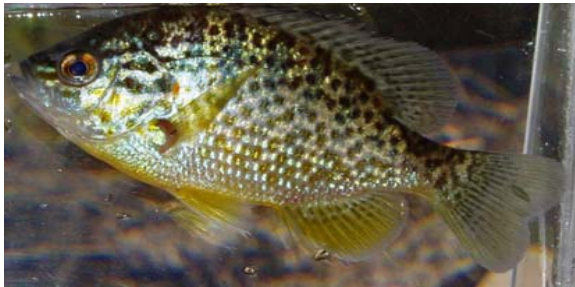
