If you are receiving this email (directly from the Department), you are confirmed as a participant in the by invitation only External Stakeholder Meeting to be held on Tuesday, October 14, 2014 at 1:00 pm in the Public Hearing Room of 401 East State Street, Trenton, New Jersey 08625. This meeting will be about the proposal to amend the Remediation Standards N.J.A.C.7:26D that are scheduled to sunset June 2, 2015.

As a recipient of this email, parking has been reserved for you in the Crescent Temple Parking Lot, Area 25. The entrance to this lot is on North Clinton Avenue approximately 400 feet north from the intersection of East State Street and North Clinton Avenue. This is not the Area 25, Visitor Lot. Please see the guard who will have the list of attendees and will direct you where to park.

In November 2013, Commissioner Martin approved moving forward with the development of a new Remediation Standards Rule to replace the existing June 2008 version. External stakeholders representing a variety of entities have been invited to be involved. Invitees include representatives of environmental groups, environmental justice advocates, county planners, municipalities, the Licensed Site Remediation Professionals Association (LSRPA), the New Jersey Business and Industry Association (NJBIA), the Commerce and Industry Association of New Jersey (CIANJ), the Site Remediation Industry Network (SRIN), the New Jersey Builders Association (NJBA), the Association of Environmental and Engineering Geologists (AEG), and the Fuel Merchants Association of New Jersey (FMANJ). Participation in this portion of the process will be restricted to those invited.

The current 2008 rule involves soil, groundwater, and surface water standards. Under consideration are the addition of standards for vapor intrusion, impact to ground water, dioxin, and extractable petroleum hydrocarbons.

The seventh meeting of the invited external stakeholder group is planned for 1:00 pm on Tuesday, October 14, 2014 in the First Floor Public Hearing Room of the New Jersey Department of Environmental Protection Building, 401 East State Street, Trenton, New Jersey 08625. The main purpose of this seventh meeting is to have a technical exchange on external stakeholder issues and concerns with the to-be proposed amendment of the remediation standards. It is to be organized and led mainly by the external stakeholders.

The Department has not yet received an agenda, but anticipates that the subject matter will come from the five draft outlines/notes/presentations received by email between September 30, 2014 and October 5, 2014. The Department anticipates the main part of the meeting will be derived from these documents. They are attached for your review.

The Department is assuming the meeting will be a series of Powerpoint presentations of the issues and concerns of the external stakeholders, which will then be considered by the Department. Note that the Department will be closed on Monday, October 13, 2014 for the Columbus Day holiday. The presenters are reminded that they need to bring sufficient copies of their presentations and handouts, and that suitable electronic versions of their presentations need

to be provided, preferably in advance. The Department is also requesting that meeting notes be taken by the external stakeholders to facilitate the Department subsequently generating a meeting summary.

Be advised that the revised meeting summary for the August 12, 2014 meeting is attached as well as a draft meeting summary for the September 16, 2014 meeting. Please review the latter prior to the meeting.

Note that, with the extension of the time frame for promulgation of the remediation standards, tentative meetings have been established for 2015. The specifics follow:
