The proposed amendment, identified as Lincoln Logistics Franklin (Program Interest No. 435437, Activity No. AMD210002) would create a new discharge to groundwater (DGW) sewer service area (SSA) of 91.03 acres to serve a proposed industrial development consisting of three (3) warehouse buildings and an onsite subsurface sewage disposal system located on Block 61, Lots 5 & 6, in Franklin Township, Warren County. The project will generate a projected wastewater flow of 16,496 gallons per day (gpd) based on flow calculated in accordance with N.J.A.C. 7:9A-7.4. A public notice of the proposed amendment was previously published in the February 21, 2023 New Jersey Register at 55 N.J.R. 324(a).
