REVISION TO THE ATLANTIC COUNTY, MERCER COUNTY, SUSSEX COUNTY AND TRI-COUNTY WATER QUALITY MANAGEMENT PLANS

TAKE NOTICE that on pursuant to the provisions of the Water Quality Planning Act, N.J.S.A.58:11A-1 et seq, and the Statewide Water Quality Management Planning rules, N.J.A.C. 7:15-3.5, a revision to the Atlantic County, Mercer County, Sussex County and Tri-County Water Quality Management (WQM) Plans was adopted by the Department. This revision updates the digital sewer service area (SSA) mapping to correct minor errors within the mapping so that it is consistent with the appropriate adopted Areawide Water Quality Management Plans (WQMP) and Wastewater Management Plans (WMP) per N.J.A.C. 7:15-3.5(b)1.

Within the Atlantic County WQM Planning Area in Galloway Township, Atlantic County a correction has been made to correctly identify the Sewer Service Area (SSA) of Galloway National Golf Club (NJ0109886) located on Block 1169.01, Lot 24. The SSA is limited to the existing clubhouse located on Block 1169.01, Lot 24 as identified in the amendment to the Galloway Township WMP that was adopted June 13, 1997.

Within the Mercer County WQM Planning Area in Lawrence Township, Mercer County a correction has been made to identify an area as "General Service area for wastewater facilities with planning flows of less than 2,000 gallons per day which discharge to groundwater" that was previously incorrectly labeled as Lawrence Township SSA.

Within the Sussex County WQM Planning Area in Lafayette Township, Sussex County a correction has been made to correctly identify the TMB Partners SSA as identified in the revision to the Sussex County-Wide WMP that was adopted March 3, 2003.

Within the Tri-County WQM Planning Area in Burlington Township and Burlington City, Burlington County a correction has been made to correctly identify the SSA boundaries of the Central Ave Wastewater Treatment Plant (WTP) (NJ0021709) and the Burlington City Sewage Treatment Plant (STP) (NJ0024660) as depicted in the Burlington City and Burlington Township WMP that was adopted January 31, 1991.

Within the Tri-County WQM Planning Area a correction has been made to add Block 303, Lot 8.02 (Springfield Rest Area) located in Springfield Township, Burlington County to the SSA of the Central Ave WTP (NJ0021709) as identified in an amendment to the Tri-County WQM Plan that was adopted September 16, 1999.

Within the Tri-County WQM Planning Area in Greenwich Township, Gloucester County a correction has been made to correctly identify and delineate the boundaries of the Greenwich Township STP (NJ0030333) SSA. The SSA was previously incorrectly identified as being part of the Gloucester County Utilities Authority STP (NJ0024686). The Greenwich Township WMP that depicts this area was adopted on January, 29, 2004.

Corrections to the SSA attribute table have been made to correct/update the WMP, FACNAME, WMPAGCY and NJDPESFL fields to indicate the appropriate plans, facilities, agencies and NJPDES permitted flow rates.
