## INSTRUCTIONS FOR DIRECTORS AND EXECUTIVE OFFICERS STATEMENT OF INTEREST

## **Business Enterprise**

Name and address: Give the legal name and address of the business enterprise.

Position:	List all positions held in the business enterprise by reporting person, his/her spouse or his/her minor children, identifying who holds the position.
Interest:	Specify the type of business and the nature and approximate percentage of ownership held by the reporting person, his/her spouse or his/her minor children. State the nature of any other form of influence exercised by the reporting person over the management or policies of the business enterprise. Specify if there is an indebtedness owed to or from the business enterprise by the reporting person, his/her spouse or his/her minor children, if the aggregate equals or exceeds the amount prescribed by regulation.
