This matter having been opened by the Bureau of Fraud Deterrence, Department of Banking and Insurance of the State of New Jersey, upon information indicating that Respondent, Scott Greenberg, D.C., currently residing at 77 Old Georgetown Road, Princeton, New Jersey may have violated the provisions of N.J.S.A. 17:33A-4; and

WHEREAS, Respondent, Scott Greenberg, D.C. between February 4, 2010 and July 27, 2011, did knowingly conspire to use individuals known as "runners" to solicit numerous individuals known as "clients," to his practice, Central Jersey Chiropractic and Rehabilitation Centre for the purpose of performing medical services and submitting numerous claims to various insurance carriers; and

WHEREAS, the above conduct constitutes violations of N.J.S.A. 17:33A-1 et seq. and any future violation of N.J.S.A. 17:33A-1, et seq. shall be considered to be a subsequent offense; and

WHEREAS, Respondent has been informed that he has a right to notice and to request a hearing, in accordance with the Administrative Procedure Act N.J.S.A. 52:14B-1 et seq., on the violations alleged herein before a civil administrative penalty is imposed; and

WHEREAS, Respondent understands these rights and has voluntarily waived the right to notice and to a formal legal proceeding in this matter; and

WHEREAS, Respondent consents to pay a civil administrative penalty pursuant N.J.S.A. 17:33A- 5 in the amount of \$450,000.00 and surcharge pursuant to N.J.S.A. 17:33A-5.1 in the amount of \$22,500.00 and attorney fees in the amount of \$27,500.00 pursuant to N.J.S.A. 17:33A- 5(c) with the total amount of \$500,000.00 being due immediately by certified check, bank check or money order made payable to the "Commissioner, Department of Banking and Insurance". This signed order and the payment in the entire amount shall be returned to Anna M. Lascrain, Deputy Attorney General, Richard J. Hughes Justice Complex, 25 Market Street, P.O. Box 117, Trenton, NJ 08625-0117; and

IT FURTHER APPEARING that the matter is suitable for resolution upon the consent of the parties and that Respondent and the Bureau of Fraud Deterrence desire to terminate this matter without further hearing or litigation, and for further good cause appearing;

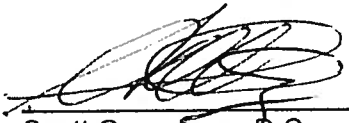
ORDERED AND AGREED as follows:

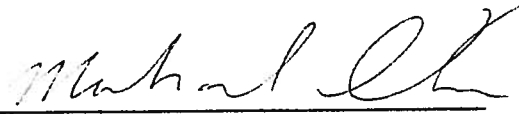
1. Pursuant to N.J.S.A. 17:33A-5(c), a civil administrative penalty of \$450,000.00 is imposed on Respondent, Scott Greenberg, D.C.
2. Pursuant to N.J.S.A. 17:33A-5.1, Respondent shall pay to the Commissioner, Department of Banking and Insurance, a surcharge equal to five (5%) percent of the settlement amount, which is \$22,500.00 such amount to be in addition to the civil administrative penalty. Respondent further agrees to pay attorney fees pursuant to N.J.S.A. 17:33A- 5(c) in the amount of \$27,500.00.
3. Pursuant to N.J.S.A. 17:33A-10(c), a copy of this Consent Order shall be provided to the appropriate licensing authority.

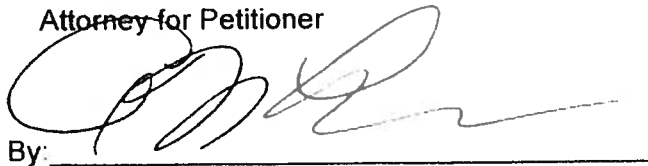
