insured vehicle would be garaged in this State when she actually resided in Philadelphia, Pennsylvania, for the purpose of obtaining a motor vehicle insurance policy;

IT IS HEREBY STIPULATED AND AGREED that, Defendant Kierstin C. Dwornick admits that she knowingly made written or oral statements to CURE on the July 27, 2012 automobile application that she did not disclose Ashot Gabrielants as a household resident of the policy address and/or driver of the insured vehicle;

IT IS FURTHER HEREBY STIPULATED AND AGREED that this conduct constitutes two violations of <u>N.J.S.A.</u> 17:33A-4, and that any future violation of the New Jersey Insurance Fraud Prevention Act shall be considered a subsequent violation; and

IT IS FURTHER HEREBY STIPULATED AND AGREED that Defendant Dwornick shall pay a total sum of \$3,125.00 to the Commissioner of the New Jersey Department of Banking and Insurance.
