ORDER FOR FINAL JUDGMENT

This matter having been brought before the Court by John J. Hoffman, Acting Attorney General of the State of New Jersey, Attorney for the Plaintiff, Commissioner of the New Jersey Department of Banking and Insurance ("The Commissioner"), Anna M. Lascurain, Deputy Attorney General appearing, and the Commissioner having filed a complaint on November 12, 2013 against Andriana Giraldo-Henao (the "Defendant") for a violation of N.J.S.A. 17:33-A et seq., The Insurance Fraud

Prevention Act (the "Fraud Act"), specifically presenting a false statement to Hartford Insurance Company;

WHEREAS, a bench trial was held before the Honorable Noah Bronkesh, J.S.C. on October 20, 2015 pursuant to the Fraud Act;

WHEREAS, for the reasons set forth on the record on October 20, 2015, the Court found that the defendant committed a violation of the Fraud Act by providing a false statement to an insurance carrier in violation of N.J.S.A 17:33A et seq.;

WHEREAS, the Court awarded the Commissioner a civil penalty in the amount of \$500.00;

WHEREAS, the Commissioner is awarded a statutory surcharge of \$1000.00 pursuant to N.J.S.A. 33A-5.1 and an award of \$ **20,000.00** in attorney's fees pursuant to the accompanying Certification of Deputy Attorney General Anna M. Lascurain, subject to the approval of the Court; and

IT IS ON THIS 20th DAY OF November 2015 For the reasons stated in the Memorandum of Decision.

ORDERED that Final Judgment in favor of the Commissioner entered in the amount of \$ **21,000.00** against the Defendant. This amount consists of attorney's fees of \$ **20,000.00** , pursuant to N.J.S.A. 17:33A-5; a civil penalty pursuant to N.J.S.A. 17:33A-5a; and a statutory surcharge of \$1000.00 pursuant to N.J.S.A. 33A-5.1.

IT IS FURTHER ORDERED that a copy of this Order be served upon all parties within 10 days of the date hereof.
