Specifically, Defendant knowingly failed to list her daughter, K.J., a licensed, household-resident driver, on the application for her automobile insurance policy, in violation of N.J.S.A. 17:33A-4(a)(3) and N.J.S.A. 17:33A-4(a)(4)(b).

FINAL JUDGMENT is on this **19th** day of **March** 2024, entered in the amount of \$8,605.00 against Defendant and in favor of Plaintiff, Justin Zimmerman, Acting Commissioner of the New Jersey Department of Banking and Insurance.
