NOTICE TO CLAIMANTS AND PARTIES IN INTEREST OF THE VESTA RECEIVERSHIPS

RE: The Texas Department of Insurance v. Vesta Fire Insurance Corporation, et al.; Cause No. D-1-GN-06-002366; In the 126th Judicial District Court of Travis County, Texas; Receivership Nos. 526-530 ("the receivership proceedings")

On August 1, 2006, the receivership estate of Vesta Fire Insurance Corporation or its affiliates, Shelby Casualty Insurance Company, The Shelby Insurance Company, Texas Select Lloyds Insurance Company, and Select Insurance Services, Inc., (collectively referred to as the "Vesta Receiverships") were placed in permanent receivership for the purposes of liquidation by order of the 126th Judicial District Court of Travis County, Texas ("receivership court") under its Order Appointing Liquidator and Permanent Injunction ("Liquidation Order.") The Texas Commissioner of Insurance has been appointed Receiver of the Vesta Receiverships and has designated Prime Tempus, Inc. as Special Deputy Receiver ("SDR.")

All policies of insurance for the Vesta Receiverships were cancelled effective August 24, 2006.

The receivership court has set a CLAIM FILING DEADLINE of 11:59 p.m., C.S.T. on November 30, 2007 ("claims filing deadline.") Accordingly, any and all claims against the Vesta Receiverships must be postmarked or otherwise delivered to the address above on or before November 30, 2007, at 11:59 p.m., C.S.T. Failure to properly complete the proof of claim form ("POC") according to the instructions may cause your claim to be delayed or disallowed.

You can view or download copies of all orders, statutory sections, and forms mentioned in this notice, including a proof of claim, from www.sdrtxpoc.com or can request that they be mailed to you by writing to: The Vesta Receiverships, P.O. Procedures for practice before the receivership court are contained in the Supplemental Order of Reference to Master. The receivership court has set the next status conference for Monday, August 6, 2007, at 9:30 a.m. in Room 102 at 333 Guadalupe Street in Austin, Texas, 78701. You may request to be added to the service list to receive all pleadings filed and notices of future status conferences in the Vesta Receiverships by email. You can make your request to be added to the service list at www.sdrtxpoc.com. Please request notice relating to a specific company and include your name, address, phone number, fax number, and email address. If you are an attorney, please designate your client.

All claims under policies of insurance that may be covered by a guaranty association ("GA") have been referred to the appropriate GA for handling. If you need further information about whether a GA is handling your claim, there is a list of GAs included in the notices available for download or to be mailed.

All claimants who have a claim against the Vesta Receiverships must file a POC prior to the claims filing deadline for any claim, or any portion of a claim. All insureds under occurrence policies are allowed to file a POC for protection under these policies.

The Permanent Injunction and TEX. INS. CODE ANN. §21A.008 enjoins all actions against the Vesta Receiverships and applies to all persons. All direct claims against the Vesta Receiverships must be made

under a POC. All litigation in which the Vesta Receiverships are a defendant may need to be dismissed upon filing of a POC.

The Liquidation Order applies to all persons and requires them to cooperate with the SDR and volunteer information regarding claims against the Vesta Receiverships or information about property, including records, of the Vesta Receiverships. All persons are enjoined by the Permanent Injunction and the Liquidation Order from transacting any business of the Vesta Receiverships and are required to report to the Special Deputy Receiver regarding any assets.

Specifically, the SDR requests that all agents and reinsurance brokers send notice of the matters contained in this legal notice to all certificate holders, additional named insureds, and reinsurers ceded and assumed, contained in their files whose rights may be impacted by the Liquidation Order, the claims filing deadline, or the stay.
