become the institution's first EOF freshman cohort to begin college in the fall 2018. The EOF rules outline the requirements for participating institutions to minimally provide a dollar-for-dollar match against EOF Academic Year Article IV funding and this will be required in the first budget. Note also that EOF Article IV funds cannot be used to pay the salary of the EOF Program Director.

The newly recruited students will participate in the new program's first pre-freshman initial EOF summer program in preparation for beginning college in the fall 2018.

Therefore, upon selection, programs will also be considered for funding of up to \$75,000 to conduct an initial summer program.

Contingent upon the Fund's receipt of FY 2019 EOF Article IV and Article III appropriations that are equal to the current FY 2018 EOF appropriations (that is, \$14,768,000—IV and \$29,054,000—III), both institutions will also be eligible to receive a FY 2019 EOF academic year Article IV appropriation of up to \$75,000 each. In terms of Article III academic year (fall and spring semesters) undergraduate grant funding for EOF eligible students, the EOF Central Office will work with both programs to determine the maximum number of students that can be supported. Depending on the amount of available resources, it is the goal of the EOF Central Office to support 100 new students between the two new programs.

Entities that may apply for funding under the program: Institutions of higher education that wish to participate in the EOF program for the first time must be licensed by the New Jersey Office of the Secretary of Higher Education and accredited by an accrediting body recognized by the U.S. Secretary of Education. Additionally, institutions must currently participate in the New Jersey Tuition Aid Grant Program (TAG). Participation in the TAG program is designed to maximize the use of available State financial aid resources to decrease the cost of college attendance for the EOF student population.

Institutions that currently participate in the EOF program and wish to pursue funding for an additional EOF program at their institution may also apply. Applicants in this category must provide a rationale for the development of a new EOF program and demonstrate how the new EOF program will meet the needs of EOF eligible students that are not currently being met.

Procedure for eligible entities to apply for a grant under the Program: Applicants should consult the RFP information regarding what must be submitted in the plan for an EOF program. The RFP will be available on the Office of the Secretary of Higher Education/EOF program's website September 18, 2017, under "Request for New EOF Undergraduate Program" at http://www.state.nj.us/highereducation/EOF/EOF_Undergraduateprogram.shtml.

Take notice that, in compliance with the Federal Victims of Crime Act (VOCA) of 1984, 42 U.S.C. §§ 10601 et seq., the Department of Law and Public Safety (Department), Division of Criminal Justice, State Office of Victim-Witness Advocacy (DCJ/SOVWA), the Department of Law and Public Safety announces the availability and award of noncompetitive subawards to each county prosecutors' offices of victim-witness advocacy to support technology infrastructure purchases and updates, personnel, equipment, travel, training, and other one-time needs, in each county prosecutor's victim-witness advocacy office. Funding for this program was derived from the Federal VOCA Formula Grant Program, which is administered by DCJ/SOVWA pursuant to guidelines published in the Federal Register, Vol. 62, No. 77, April 27, 1997 (62 Fed. Reg. 19607-621).

Under this program, a total of \$8,400,000 was offered to the 21 county prosecutors' offices of victim-witness advocacy. Funding is provided on a reimbursement basis only and is contingent upon subrecipient application submissions, compliance with grant conditions, and satisfactory performance of services. The funding allocation is for an 18-month period from October 1, 2016 to March 31, 2018. Each county has been allocated an award amount up to \$400,000 with a 20 percent match.

Please note that funding allocations and individual subaward amounts are subject to change. Subrecipients shall recognize and agree that both the initial provision of funding and the continuation of such funding under a grant agreement is expressly depending upon the availability to the Department of Law and Public Safety of funds appropriated by the

State or Federal Legislature from State and/or Federal revenue or such other funding sources as may be applicable. A failure of the Department to make any payment under a grant agreement or to observe and perform any condition on its part to be performed under a grant agreement as a result of the failure of the State or Federal Legislature to appropriate funds shall not in any manner constitute a breach of a grant agreement by the Department or an event of default under a grant agreement and the Department shall not be held liable for any breach of a grant agreement because of the absence of available funding appropriations. In addition, future funding shall not be anticipated from the Department beyond the duration of the award period set forth in a grant agreement and in no event shall a grant agreement be construed as a commitment by the Department to expend funds beyond the termination date set in a grant agreement.

Notice of Adoption—Amendment to the Secaucus Transit Village Redevelopment Plan

Take notice that in accordance with N.J.A.C. 19:3-5.10(c), the New Jersey Sports and Exposition Authority (NJSEA) hereby publishes this notice of adoption of an amendment to the Secaucus Transit Village Redevelopment Plan. The Secaucus Transit Village Redevelopment Area, located in the Town of Secaucus, within the Hackensack Meadowlands District, comprises approximately 231 acres and is defined as the following: Block 5.01, Lots 3.01 and 3.02; Block 5.02, Lots 3.03 and 3.04; Block 5.03, Lot 3.05; Block 5.04, Lot 3.06; Block 5.05, Lots 3.07 and 3.08 (formerly identified as Block 5, Lots 3 and 5), Block 5, Lots 4 (including Lot 4.01), 6, 7.01, 7.02, 8 and 9; Block 8, Lots 1 and 2; Block 9, Lots, 8.05, 8.06, 9, 10 and 11; Block 10, Lots 6.01, 8.01, 9.01, 10, 11, 12, and 13; Block 12, Lot 1; and Block 20.01, 0.16-acre portion of Lot 16, in the Town of Secaucus.

The initial Secaucus Transit Village Redevelopment Plan was adopted by the New Jersey Meadowlands Commission (NJMC) on April 16, 2004, and amended on May 24, 2006, April 23, 2008, and October 21, 2011. The purpose of the Secaucus Transit Village Redevelopment Plan is to permit the subject area to become a transit-oriented, transit-friendly development.

On July 20, 2017, the NJSEA Board of Commissioners adopted an amendment to the Secaucus Transit Village Redevelopment Plan. The approved amendment to the Plan includes an extension of the time period for commercial off-street parking as an interim use from seven to 10 years, the commencement of which shall coincide with the issuance of a certificate of completion; an increase in the maximum number of parking spaces permitted for commercial off-street parking as an interim use from 1,100 to 2,200 within the Station Square zone; and the establishment of a requirement that any application for an interim use shall be submitted within two years of adoption of this amendment to the redevelopment plan.

Additional use limitations include the provision of a maximum height limitation of 20 feet for vehicle lifts, car stackers, and/or similar structures, and the provision of a minimum 10-foot setback from any property line for vehicle lifts, car stackers, and/or similar structures for parking vehicles.

The amendment to the Secaucus Transit Village Redevelopment Plan, adopted by the NJSEA Board of Commissioners on July 20, 2017, shall supersede all previously noted redevelopment plans for the redevelopment area.
