Executive Summary

The calendar quarter was marked by continued refinements to rules, DRP staffing and Advisory Council formation.

In order to codify the functions of the Advisory Council and to communicate its purpose and formation to the user community at large, the Forum formulated "Rules Governing the Advisory Council for the Arbitration of No-Fault Disputes". The rules were approved by the Commissioner on May 9, 2006 and made accessible to the public via the Forum's New Jersey website. The rules provide for user-member term limits, impose confidentiality restrictions on the interview and deliberation processes for new DRPs and specifically prohibit members from exerting undue influence upon DRPs by virtue of their Advisory Council status. During the 2nd quarter, the Council met in May and June. Agenda items included continuing DRP interviews, MRO Rule change recommendations and general user input.

Recurrent assessment of DRP staffing needs resulted in a decision to expand the DRP panel from 35 to 40. Five qualified candidates were identified, contracted and provided with 12 hours of DRP orientation. Three DRPs commenced hearings in June. Two others are scheduled to commence hearings in July. With the expansion, DRP regional deployment consists of 26 in the North Region, 8 in the Central Region and 6 in the South Region.

Following an exhaustive review of the MRO process, the Forum restructured No-Fault Arbitration Rule 21 to facilitate internal conflict of interest checks by MROs and to better guide users through the request process. The Commissioner approved the revised Rule with an effective date of the first day of the 3rd quarter.

In the 2nd quarter of 2006, 9,212 cases were initiated in the PIP ADR program. Of these cases, 6,201 (67%) originated in the Northern region, 1,924 (21%) in the Central region, and 1,087 (12%) in the Southern region.

Of the pending cases filed with the Forum in the PIP ADR program, 8,057 cases were concluded during the 2nd quarter by means of an award or denial of award at hearing, dismissal of the case, settlement or withdrawal. 382 were placed in abeyance by consent of the parties or by order of the court. 8,397 cases were assigned to Dispute Resolution Professionals.

1,236 cases settled during the conciliation period distributed regionally as follows: 825 in the North region, 281 in the Central region and 130 in the South region.

System-wide, the average total amount awarded in arbitration was \$4,563 comprised of \$3,474 for personal injury protection benefits and \$1,089 for attorney's fees per case. It is common practice for users to stipulate that amounts awarded by DRPs are subject to further reduction for deductibles, co-payments, prior payments and/or medical fee schedule adjustments. In such cases, the final amount paid by the respondent is less than the awarded amount.

Nineteen appeals to panels of 3 DRPs were concluded during the reporting period resulting in 11 cases affirmed, 5 vacated, 1 vacated and remanded and 2 modified.


Effective April 1, 2006 the Department certified CFO Medical Services as a Medical Review Organization. The Forum modified its case management software to add CFO as an MRO and to automate MRO rotation as required by N.J.A.C. 11:3-5.6 (c) 1. The Forum was also pleased to provide CFO with orientation training and materials to facilitate its transition into the MRO process. First Managed Care Option continued to function as a Medical Review Organization during the reporting period. Parties requested 85 MRO reviews. No DRP requests were made.

Cases Initiated

Cases are considered "filed" as of the date a Demand for Arbitration is received by the Forum. Case "initiation" occurs when an initiation letter is transmitted to the parties.

In the 2nd quarter of 2006, 9,212 cases were initiated in the PIP ADR program. Of these cases, 6,201 (67%) originated in the Northern region, 1,924 (21%) in the Central region, and 1,087 (12%) in the Southern region. See the Table below for the monthly distribution.

Disposition of Cases in the PIP ADR Program


Of the pending cases filed with the Forum in the PIP ADR program, 8,057 cases were concluded during the 2nd quarter by means of an award or denial of award at hearing, dismissal of the case, settlement or withdrawal. The table below illustrates the manner in which cases were administered and concluded in the various geographic regions.

Cases in Abeyance

Administration of certain cases is suspended by way of Court Order or consent of the parties. These cases are designated as in abeyance. Abeyances for the reporting period are shown in the table below by regional distribution and percentage.

Cases Settled within 45 Days of Initiation

Respondents are granted a conciliation period of 45 days from case initiation in which to settle claims without incurring a respondent administration fee. During the 2nd quarter, 1,236 cases settled during the conciliation period distributed regionally as follows: 825 in the North region, 281 in the Central region and 130 in the South region.

The following table illustrates that 6% to 8% of cases settle during the reconciliation period.

Dispute Resolution Professional Caseload

Continuing assessment of DRP staffing needs resulted in a decision to increase the DRP panel from 35 to 40. Three new DRPs commenced hearings in June, with two others scheduled to begin hearings in the third quarter. During the reporting period, 8,397 cases were assigned to DRPs.

Caseload activity of DRPs is represented in Appendix A.

Disposition of Cases After DRP Assignment

Following expiration of the 45-day conciliation period, cases are assigned to DRPs for disposition. After DRP appointment, a total of 6,638 cases were resolved during the quarter, resulting from a combination of DRP issued awards (which includes denials), dismissals, settlements and withdrawals.

The following table represents the distribution and outcomes of cases across the entire DRP panel during the 2^{nd} quarter of 2006 after the cases were assigned to the DRP for hearing:

Regional Awards' Percentage

As shown above, a total of 2,777 awards were issued by DRPs concerning requests for expedited relief, standard relief, fee disputes and appeals. 65% of the awards issued in the North region, 24% in the Central region and 11% in the South.



Awards as a Percentage of Claim Amount

Dispute Resolution Professionals can deny a claim in its entirety or can award all or part of an amount requested by a Claimant. For cases decided in the 2nd quarter of 2006, the graph below indicates the distribution of DRP awarded amounts, from 0% (denied/dismissed) to 100% of claim amounts.


The data presentation for 2006 is revised from previous years in that it no longer contains award data described as "more than 100%", representing claims amended upward at the time of hearing. This nomenclature was retained from reports provided to the Department by the prior administrator. However, the nomenclature is imprecise. DRPs may not award amounts greater than those claimed. For purposes of the data table and chart below, amended amounts are captured within a total amount claimed and then compared to the total amount awarded.

PIP Benefits and Attorneys' Fees Comparison

System-wide, the average total amount awarded in arbitration was \$4,563 comprised of \$3,474 for personal injury protection benefits and \$1,089 for attorney's fees per case. The graphical representation compares the data as percentages.



Award Average, Median and Dollar Range

The average amount awarded for claims other than attorneys' fees was \$3,474* per case. Awarded amounts ranged from \$0 to \$160,397. The median award during the reporting period was \$1,330.

The average amount awarded for attorneys' fees was \$1,089 per case. Awarded attorneys' fees ranged from \$0 to \$6,225. The median attorney's fee award during the reporting period was \$1,100
