Executive Summary

The National Arbitration Forum (FORUM) encourages Personal Injury Protection (PIP) practitioners to use the cost-free online case management tools including online claim filing, case management, document uploading, and award searching. All of these functions saw month-over-month increases, some as high as 24%. The continuing migration from paper to electronic reduces costs for all practioners and, ultimately, for auto insurance consumers.

The Advisory Council met once during the quarter. The Dispute Resolution Professional (DRP) panel consisted of 46 members. DRP regional deployment was as follows: 30 in the North; 8 in the Central with full caseloads and 1 with a reduced caseload; 7 in the South.

In the 3rd quarter of 2008, 13,397 cases were initiated in the PIP ADR program. Of these cases, 9,109 (68%) originated in the Northern region, 2,323 (17%) in the Central region, and 1,965 (15%) in the Southern region.

Of the pending cases filed with the FORUM in the PIP ADR program, 11,431 cases were concluded during the 3rd quarter by means of an award or denial of award (including appeals), pre-hearing dismissal of the case, settlement, or withdrawal. There were 196 cases placed in abeyance by consent of the parties or by order of the court. There were 11,838 cases assigned to DRPs.

During the 3rd quarter, 3,189 cases settled during the conciliation period distributed regionally as follows: 2,130 in the North region, 581 in the Central region, and 478 in the South region.

System-wide, the average total amount awarded in arbitration was \$5,868 comprised of \$4,684 for PIP benefits and \$1,184 for attorney's fees per case. It is common practice for users to stipulate that amounts awarded by DRPs are subject to further reduction for deductibles, co-payments, prior payments and/or medical fee schedule adjustments. In such cases, the final amount paid by the respondent for PIP benefits is less than the awarded amount.

Twenty-six (26) appeals to panels of 3 DRPs were concluded during the reporting period. Thirteen (13) involved awards rendered in the North Region, seven (7) involved awards rendered in the Central Region, and six (6) involved awards rendered in the South Region. Thirty-one (31%) percent of appeals resulted in some form of modification, vacation, or remand.


During the reporting period, parties requested 93 Medical Review Organization (MRO) reviews. The requests were apportioned among the three current MROs on a random rotating basis. No DRP requests were made.

Cases Initiated

Cases are considered "filed" as of the date a Demand for Arbitration is received by the FORUM. Case "initiation" occurs when an initiation letter is transmitted to the parties.

In the 3rd quarter of 2008, 13,397 cases were initiated in the PIP ADR program. Of these cases, 9,109 (68%) originated in the Northern region, 2,323 (17%) in the Central region, and 1,965 (15%) in the Southern region. See the table below for the monthly distribution.

Disposition of Cases in the PIP ADR Program

Of the pending cases filed with the FORUM in the PIP ADR program, 11,431 cases were concluded during the 3rd quarter by means of an award or denial of award (including appeals), pre-hearing dismissal of the case, settlement, or withdrawal. The table below illustrates the manner in which cases were administered and concluded in the various geographic regions.



Cases in Abeyance

Administration of certain cases is suspended by way of Court Order or consent of the parties. These cases are designated as in abeyance. Abeyances for the reporting period are shown in the table below by regional distribution and percentage.

Cases Settled within 45 Days of Initiation

Respondents are granted a conciliation period of 45 days from case initiation in which to settle claims without incurring a respondent administration fee. During the 3rd quarter, 3,189 cases settled during the conciliation period distributed regionally as follows: 2,130 in the North region, 581 in the Central region, and 478 in the South region.

The following table illustrates that 11% to 12% of cases settled during the reconciliation period.

Dispute Resolution Professional Caseload

For the quarter, the DRP panel consisted of 46 members. The DRPs were regionally deployed as follows: 30 in the North; 8 in the Central with full caseloads and 1 with a reduced caseload; 7 in the South.

Caseload activity of DRPs is represented in Appendix A.

Disposition of Cases after DRP Assignment

Following expiration of the 45-day conciliation period, cases are assigned to DRPs for disposition. After DRP appointment, a total of 7,843 cases were resolved during the quarter, resulting from a combination of DRP issued awards (which includes denials and appeals), pre-hearing dismissals, settlements and withdrawals.

The following table represents the distribution and outcomes of cases across the entire DRP panel during the 3rd quarter of 2008 after the cases were assigned to the DRP for hearing.

Regional Awards' Percentage

As shown above, a total of 2,579 awards were issued by DRPs concerning requests for expedited relief, standard relief, fee disputes, and appeals. Of the awards, 67% were issued in the North region, 17% in the Central region, and 16% in the South.



Awards as a Percentage of Claim Amount

DRPs can deny a claim in its entirety or can award all or part of an amount requested by a Claimant. For cases decided in the 3rd quarter of 2008, the graph below indicates the distribution of DRP awarded amounts, from 0% (denied/dismissed) to 100% of claimed amounts.

The data presentation for 2006 and thereafter was revised from previous years in that it no longer contains award data described as "more than 100%", representing claims amended upward at the time of hearing. This nomenclature was retained from reports provided to the Department by the prior administrator. However, the nomenclature is imprecise. DRPs may not award amounts greater than those claimed. For purposes of the data table and chart below, amended amounts are captured within a total amount claimed and then compared to the total amount awarded.



PIP Benefits and Attorney's Fees Comparison

System-wide, the average total amount awarded in arbitration was \$5,868 comprised of \$4,684 for personal injury protection benefits and \$1,184 for attorney's fees per case. The graphical representation compares the data as percentages.



Award Average, Median and Dollar Range

The average amount awarded for claims other than attorney's fees was \$4,684* per case. Awarded amounts ranged from \$0 to \$504,656. The median award during the reporting period was \$1,248.

The average amount awarded for attorney's fees was \$1,184 per case. Awarded attorney's fees ranged from \$0 to \$7,500. The median attorney's fee award during the reporting period was \$1,200.

Appeals

Twenty-six (26) appeals to panels of 3 DRPs were concluded during the reporting period. Thirteen (13) involved awards rendered in the North Region, seven (7) involved awards rendered in the Central Region, and six (6) involved awards rendered in the South Region. Thirty-one (31%) percent of appeals resulted in some form of modification, vacation, or remand. The following table reports the results.

Medical Review Organization Report



Online Case Management and Award Searching

This section of the report provides usage data for the FORUM's free web-based case management tools for PIP practitioners. At the inception of the No-Fault Dispute Resolution Program, the FORUM launched a website at www.nj-no-fault.com as a free customer service. It enables PIP practitioners to access rules and forms, file and manage their cases online, upload cases documents, and search prior decisions. The chart below compares usage for the past four calendar quarters.

2008 Q3 Hightlights

- Overall, the NJ PIP website webtool usage increased an average of 24% from Q2 '08
- NJ PIP website had 795,095 total page views (PVs) in Q3 '08, with a significant increase of 23.4% from Q2 '08.
- Filer case management application had 150,156 PVs in Q3 '08; which is up 24.2% from Q2 '08.
- Filer document upload application Has gone up 5.2% since Q2 '08
- Award search application had 36,933 PVs in Q3 '08; with an increase of 19.7% from Q2 '08.
- 42,383 PDFs were accessed in Q3 '08; with an increase of 15.8% from Q2 '08.
