Maidencreek Township Authority Wastewater Treatment Plant Modification Ontelaunee Township, Berks County, Pennsylvania

PROCEEDINGS

This docket is issued in response to an Application submitted to the Delaware River Basin Commission (DRBC or Commission) by Systems Design Engineering, Inc. on behalf of the Maidencreek Township Authority (the docket holder) on June 9, 2014 (Application) for review of a modification to the docket holder's existing wastewater treatment plant (WWTP). The Pennsylvania Department of Environmental Protection (PADEP) issued National Pollutant Discharge Elimination System (NPDES) Permit No. PA0070271 for the project WWTP on February 25, 2011 and Water Quality Management (Part II) Permit No. 0607402 A-1 for the proposed WWTP modification project on July 16, 2014.

The Application was reviewed for inclusion of the project in the Comprehensive Plan and approval under Section 3.8 of the *Delaware River Basin Compact*. The Berks County Planning Commission has been notified of pending action. A public hearing on this project was held by the DRBC on December 9, 2014.

A. DESCRIPTION

- 1. <u>Purpose</u>. The purpose of this docket is to approve the addition of a chemical feed system for phosphorus treatment at the docket holder's existing 0.8 million gallons per day (mgd) WWTP. No other modifications are proposed and the WWTP will remain at an average annual flow of 0.8 mgd.
- **Location**. The project WWTP is located off Willow Creek Road, approximately ¼ mile northwest of its intersection with East Hullers Lane in Ontelaunee Township, Berks County, Pennsylvania. The project WWTP discharges to Willow Creek, which is tributary to Maiden Creek, which is tributary to the Schuylkill River, at River Mile 92.47 86.1 0.6 1.0 (Delaware River Schuylkill River Maiden Creek Willow Creek).

The project outfall is located in the Schuylkill River Watershed as follows:

3. <u>Area Served</u>. The project WWTP will continue to serve Maidencreek and Ontelaunee Townships, in Berks County, Pennsylvania.

For the purpose of defining the Area Served, the Application is incorporated herein by reference consistent with conditions contained in the DECISION section of this docket.

4. Physical features.

- **a.** <u>Design criteria</u>. The existing WWTP is designed to treat an average annual flow of 0.8 mgd and a monthly hydraulic design capacity of 1.0 mgd via an oxidation ditch treatment system. The proposed modification consists of adding a chemical feed system to treat for phosphorous. No other modifications to the WWTP facilities or the design capacity are proposed.
- **b.** <u>Facilities</u>. The existing WWTP consists of a comminutor, an oxidation ditch, two (2) final clarifiers, ultraviolet light (UV) disinfection, a sludge pump station, aerobic digesters/sludge holding tanks, and sludge thickening.

The proposed modification consists of adding a chemical feed system for the removal of phosphorous, which will be accomplished by the addition of aluminum chloride to the oxidation ditch discharge prior to the final clarifiers.

The existing WWTP facilities are located outside the 100-year flood zone.

Wasted sludge will continue to be hauled off-site by a licensed hauler for disposal at a State-approved facility.

- **c.** <u>Water withdrawals</u>. The potable water supply in the project service area is provided by groundwater wells owned and operated by docket holder, as described in detail in Docket No. D-1991-058 CP-4, which was approved by the DRBC on September 27, 2006.
- **d.** <u>NPDES Permit / DRBC Docket</u>. PADEP issued NPDES Permit No. PA0070271 for the WWTP on February 25, 2011, which includes final effluent limitations for an annual average flow of 0.8 mgd to surface waters classified by the PADEP as Cold Water Fishery (CWF). The following average monthly effluent limits are among those listed in the NPDES permit and meet or are more stringent than the effluent requirements of the DRBC.

e. Relationship to the Comprehensive Plan. The existing WWTP was included in the Comprehensive Plan by Docket No. D-1978-014 CP-1 on March 22, 1978. The WWTP was expanded by DRBC Docket No. D-2000-028 CP-1 on September 28, 2000. DRBC Application No. D-2000-028 CP-2 for a Total Dissolved Solids Determination was not approved. This docket (D-2000-028 CP-3) approves a modification to the WWTP.

B. FINDINGS

This docket approves the addition of a chemical feed system to the docket holder's existing 0.8 mgd WWTP for phosphorous treatment.

At the WWTP discharge location, Willow Creek has an estimated seven-day low flow with a recurrence interval of ten years (Q-7-10) of 1.4 mgd (2.1 cfs). The ratio of this low flow to the design wastewater discharge from the WWTP (1.0 mgd) is 1.4 to 1.

The nearest surface water intake of record for public water supply downstream of the project discharge is operated by the City of Pottstown, and is located on the Schuylkill River approximately 32 miles downstream of the project discharge.

The project does not conflict with the Comprehensive Plan and is designed to prevent substantial adverse impact on the water resources related environment, while sustaining the current and future water uses and development of the water resources of the Basin.

The effluent limits in the NPDES Permit are in compliance with Commission effluent quality requirements, where applicable.

The project is designed to produce a discharge meeting the effluent requirements as set forth in the WQR of the DRBC.

C. DECISION

- I. Effective on the approval date for Docket No. D-2000-028 CP-3 below:
- a. The project described in Docket No. D-2000-028 CP-1 is removed from the Comprehensive Plan to the extent that it is not included in Docket No. D-2000-028 CP-3; and

- b. Docket No. D-2000-028 CP-1 is terminated and replaced by Docket No. D-2000-028 CP-3.
- c. The project and the appurtenant facilities described in the Section A "Physical Features" of this docket shall be added to the Comprehensive Plan.
- II. The project and appurtenant facilities as described in the Section A "Physical features" of this docket are approved pursuant to Section 3.8 of the *Compact*, subject to the following conditions:
- a. Docket approval is subject to all conditions, requirements, and limitations imposed by the PADEP in its NPDES permit and Part II permit, and such conditions, requirements, and limitations are incorporated herein, unless they are less stringent than the Commission's.
- b. The facility and operational records shall be available at all times for inspection by the DRBC.
- c. The facility shall be operated at all times to comply with the requirements of the WOR of the DRBC.
- d. The docket holder shall comply with the requirements contained in the EFFLUENT TABLES in Section A.4.d. of this docket. The docket holder shall submit the required monitoring results <u>electronically</u> to the DRBC Project Review Section via email <u>aemr@drbc.state.nj.us</u> on the <u>Annual Effluent Monitoring Report Form</u> located at this web address: http://www.state.nj.us/drbc/programs/project/application/index.html. The monitoring results shall be submitted annually, absent any observed limit violations, by January 31. If a DRBC effluent limit is violated, the docket holder shall submit the result(s) to the DRBC within 30 days of the violation(s) and provide a written explanation that states the action(s) the docket holder has taken to correct the violation(s) and protect against any future violations.
- e. Except as otherwise authorized by this docket, if the docket holder seeks relief from any limitation based upon a DRBC water quality standard or minimum treatment requirement, the docket holder shall apply for approval from the Executive Director or for a docket revision in accordance with Section 3.8 of the *Compact* and the *Rules of Practice and Procedure*.
- f. If at any time the receiving treatment plant proves unable to produce an effluent that is consistent with the requirements of this docket approval, no further connections shall be permitted until the deficiency is remedied.
- g. Nothing herein shall be construed to exempt the docket holder from obtaining all necessary permits and/or approvals from other State, Federal or local government agencies having jurisdiction over this project.
- h. Sound practices of excavation, backfill and reseeding shall be followed to minimize erosion and deposition of sediment in streams.

- i. Within 10 days of the date that construction of the project has started, the docket holder shall notify the DRBC of the starting date and scheduled completion date.
- j. Within 30 days of completion of construction of the approved project, the docket holder is to submit to the attention of the Project Review Section of DRBC a Construction Completion Statement ("Statement") signed by the docket holder's professional engineer for the project. The Statement must (1) either confirm that construction has been completed in a manner consistent with any and all DRBC-approved plans or explain how the as-built project deviates from such plans; (2) report the project's final construction cost as such cost is defined by the project review fee schedule in effect at the time the application was made; and (3) indicate the date on which the project was (or is to be) placed in operation. In the event that the final project cost exceeds the estimated cost used by the docket holder to calculate the DRBC project review fee, the statement must also include (4) the amount of any outstanding balance owed for DRBC review. The outstanding balance will equal the difference between the fee paid to the Commission and the fee calculated on the basis of the project's final cost, using the formula and definition of "project cost" set forth in the DRBC's project review fee schedule in effect at the time application was made.
- k. The WWTP modification shall be completed within three years of approval of this docket or the docket holder shall demonstrate to the Executive Director that it has expended substantial funds (in relation to the cost of the project) in reliance upon this docket approval. If the modifications have not been completed by the expiration date of this docket and the docket holder does not submit a cost analysis demonstrating substantial funds have been expended, Commission approval of the modification to the existing WWTP shall expire. If the docket expires under this condition, the docket holder shall file a new application with the Commission and receive Commission approval prior to initiating construction of any modifications.
- 1. The docket holder is permitted to treat and discharge wastewaters as set forth in the Area Served Section of this docket, which incorporates by reference Sections B (Type of Discharge) and D (Service Area) of the docket holder's Application to the extent consistent with all other conditions of this DECISION Section.
- m. The docket holder shall discharge wastewater in such a manner as to avoid injury or damage to fish or wildlife and shall avoid any injury to public or private property.
- n. No sewer service connections shall be made to newly constructed premises with plumbing fixtures and fittings that do not comply with water conservation performance standards contained in Resolution No. 88-2 (Revision 2).
- o. Nothing in this docket approval shall be construed as limiting the authority of DRBC to adopt and apply charges or other fees to this discharge or project.
- p. The issuance of this docket approval shall not create any private or proprietary rights in the waters of the Basin, and the Commission reserves the right to amend, suspend or rescind the docket for cause, in order to ensure proper control, use and management of the water resources of the Basin.

- q. Unless an extension is requested and approved by the Commission in advance, in accordance with paragraph 11 of the Commission's Project Review Fee schedule (Resolution No. 2009-2), the docket holder is responsible for timely submittal of a docket renewal application on the appropriate DRBC application form at least 12 months in advance of the docket expiration date set forth below. The docket holder will be subject to late charges in the event of untimely submittal of its renewal application, whether or not DRBC issues a reminder notice in advance of the deadline or the docket holder receives such notice. In the event that a timely and complete application for renewal has been submitted and the DRBC is unable, through no fault of the docket holder, to reissue the docket before the expiration date below (or the later date established by an extension that has been timely requested and approved), the terms and conditions of the current docket will remain fully effective and enforceable against the docket holder pending the grant or denial of the application for docket approval.
- r. The Executive Director may modify or suspend this approval or any condition thereof, or require mitigating measures pending additional review, if in the Executive Director's judgment such modification or suspension is required to protect the water resources of the Basin.
- s. Any person who objects to a docket decision by the Commission may request a hearing in accordance with Article 6 of the Rules of Practice and Procedure. In accordance with Section 15.1(p) of the Delaware River Basin Compact, cases and controversies arising under the Compact are reviewable in the United States district courts.
- t. The docket holder may request of the Executive Director in writing the substitution of specific conductance for TDS. The request should include information that supports the effluent specific correlation between TDS and specific conductance. Upon review, the Executive Director may modify the docket to allow the substitution of specific conductance for TDS monitoring.
- u. The docket holder is prohibited from treating/pre-treating any hydraulic fracturing wastewater from sources in or out of the Basin at this time. Should the docket holder wish to treat/pre-treat hydraulic fracturing wastewater in the future, the docket holder will need to first apply to the Commission to renew this docket and be issued a revised docket allowing such treatment and an expanded service area. Failure to obtain this approval prior to treatment/pre-treatment will result in action by the Commission.
