## **SYNOPSIS**

On May 30, 2012, the petitioner filed a request for emergent relief with regard to the respondent Board's refusal to allow him to participate in an awards ceremony scheduled for June 13, 2012, on the grounds that petitioner had accumulated more than nineteen absent days due to illness. The case was scheduled for hearing on June 11, 2012. Petitioner received appropriate notice of the hearing, but failed to appear and offered no explanation for his non-appearance. Accordingly, the ALJ dismissed the petition with prejudice.

Upon review of the file, the Commissioner concurred with the ALJ that this matter is appropriately dismissed for failure to prosecute. Accordingly, the Commissioner dismissed the within appeal.
