Saddle River Board of Education : DECISION FOR FAILURE Bergen County : TO ATTEND TRAINING

WHEREAS, the School Ethics Act, <u>N.J.S.A.</u> 18A:12-21 <u>et. seq.</u> was enacted by the New Jersey State Legislature to ensure and preserve public confidence in school board members and school administrators and to provide specific ethical standards to guide their conduct; and

WHEREAS, N.J.S.A. 18A:12-33 requires each newly elected or appointed board member to complete, during the first year of the member's first term, a training program offered by the New Jersey School Boards Association (NJSBA) regarding the skills and knowledge necessary to serve as a school board member or charter school trustee; and

WHEREAS, Rosemarie Arnold was newly elected or appointed in May 2006 to a local school board or charter school board and therefore, had until May 2007, to complete the training requirement; and

WHEREAS, the NJSBA mails correspondence to all new board members who have failed to register for or attend an orientation and did mail such correspondence to this board member on July 31, 2006, and December 28, 2006; and

WHEREAS, the NJSBA conducted seven training sessions between April 2006 and March 2007 at varying locations and continuously published the dates and times of the sessions in its publication, *School Board Notes*; and

WHEREAS, the last training session to fulfill the requirement was held on September 7-9, 2007; and

WHEREAS, the Commission issued an Order on August 17, 2007, directing Ms. Arnold to Show Cause why she had not attended training up until that time; and

WHEREAS, Ms. Arnold responded to the Order on August 20, 2007 and indicated that she attended the training session on December 9, 2006; and

WHEREAS, Mark A. Bonjavanni from the NJSBA certified that Ms. Arnold had arrived late to the December 9, 2006 training session and had missed the legal portion of the training; and

WHEREAS, the Commission notified Ms. Arnold that the Commission would discuss this matter at its September 25, 2007 meeting; and

WHEREAS, Ms. Arnold has failed to attend the legal portion of the required training program during the first year of the board member's first term as required in N.J.S.A. 18A:12-33; and

WHEREAS, at its September 25, 2007 meeting, the Commission found that her failure to attend the legal portion of the board member training from April 2006 to March 2007 constituted a clear violation of N.J.S.A. 18A:12-33; and

WHEREAS, at its September 25, 2007 meeting, the Commission found that the appropriate penalty for the violation was suspension from the board until she attends the legal portion of the October 23, 2007 training session and removal if she failed to attend the legal portion of the October 23, 2007 session and recommended such penalty to the Commissioner of Education; and

WHEREAS, Ms. Arnold indicated that she could not attend the October 23, 2007 training session because of inability to obtain child care for her children and requested the Commission to reconsider its September 25, 2007 recommendation to the Commissioner; and

WHEREAS, at the October 30, 2007 meeting, the Commission reconsidered its decision and voted to amend its penalty determination finding that the appropriate penalty for the violation was suspension from the board until Ms. Arnold attends the legal portion of the November 16, 2007 training session and removal if she fails to attend the legal portion of the November 16, 2007 training session; and

NOW THEREFORE BE IT RESOLVED that the School Ethics Commission finds that Rosemarie Arnold violated the <u>N.J.S.A.</u> 18A:12-33 of the School Ethics Act and recommends that the Commissioner of Education impose a penalty of suspension from the board until she attends the legal portion of the November 16, 2007 training session and removal if she fails to attend the legal portion of the November 16, 2007 training session.
