

FAQ

The New Jersey Department of Education offers unpaid summer internships to students in college. The program allows you to explore career options as well as develop your personal and professional skills. As a student intern, you will be exposed to the Department's work environment and will learn about the mission and responsibilities of various divisions and offices.

The Volunteer Summer Internship Program can enrich your future. Some of the benefits include:

- Career exploration early in your academic studies.
- Exposure to new and emerging education trends
- Academic credit for the work you perform. (This is determined by your academic institution.)
- Work experience which will enhance your ability to obtain paying jobs in the future.

Am I Eligible?

You are eligible to participate as a Student Intern if you are enrolled, at least half-time, in:

- a junior or community college;
- a four-year college or university; or
- any other accredited educational institution.

What Types of Positions Are Available for Student Volunteers?

Student Interns are involved in professional projects and work activities related to their academic studies. These activities run the gamut from developing computer skills to policy or research oriented projects involving such diverse topics regarding education initiatives, concerns, and legislative issues. Depending upon the selected office or bureau student internship assignments will differ, but all promise to be stimulating and rewarding.

We recommend that student interns develop a work agreement in collaboration with their college and placement office. The agreement should outline the responsibilities of each partner. It may also identify the type(s) of assignment(s) and the conditions under which you will work.

For How Long and When Would I Work?

Most student interns will work for two to three months. Your work may be performed during the school year and/or during summer or school vacation periods. The nature of your volunteer assignment as well as your weekly work schedule should be part of your work agreement.

Will I be Paid?

No. The New Jersey Department of Education will assist you in your attempts to secure college course credit.
