



A proficiency rate is calculated by summing the count of students who scored either proficient or advanced proficient on the assessment and dividing by the count of valid test scores.

College and Career Readiness



Additionally, this school is meeting **80%** of its performance targets in the area of College and Career Readiness.



This graph presents the count of students who were 'on roll' by grade in October of each school year.






Enrollment by Ethnic/Racial Subgroup










Scholastic Assessment Test (SAT) Results


