



College and Career Readiness



Additionally, this school is meeting **100%** of its performance targets in the area of College and Career Readiness.



This graph presents the count of students who were 'on roll' by grade in October of each school year.






Enrollment by Ethnic/Racial Subgroup







Students in high schools begin to demonstrate college readiness behaviors long before they actually graduate from high school. Among those behaviors are taking college entrance exams and challenging themselves with rigorous course work. 


Scholastic Assessment Test (SAT) Results


