




### English Language Arts and Mathematics Performance Trends









**Students enrolled in one or more classes by discipline:**











## Accountability

### Accountability Summary by Student Group - 2023-24 School Year

The NJDOE is required under ESSA to identify schools for Targeted Support and Improvement (TSI) annually and for Additional Targeted Support and Improvement (ATSI) every three years. Both TSI and ATSI identifications are based on how student groups within schools perform. Math instruction is comprised of Envision Math, a problem based system which encourages critical thinking. The science program is aligned to Next Generation Science Standards. Technology is incorporated through the use of ST Math, Achieve 3000, Age of Learning, and IXL Math.

Safety is a priority at Arleth Elementary School. We have a new security vestibule and a full time security guard. There is also a police officer assigned to the building on a daily basis. The building is equipped with cameras. Monthly drills are conducted in order to ensure the safety of the students.



### Technology and STEM:

Classrooms in Arleth Elementary School have either a SMART Board or an interactive Flat Screen. Rooms are also equipped with Cisco Room Kits and document cameras. We are a one-to-one device school. Devices consist of both Chromebooks and iPads. Devices are used to help students engage in the following programs: My Math Academy, My Reading Academy, ST Math, Achieve 3000, and IXL Math. STEM lessons are taught by the Gifted and Talented teacher on a rotating basis. In addition, a STEM lab is located in the Gifted and Talented room.
