

## Minutes of the Government Records Council September 29, 2020 – Closed Session

The Council convened in closed session at 1:43 p.m. telephonically. In attendance were: Robin Berg Tabakin, Esq. (Chairwoman), Jennifer Simons Esq. (designee of Department of Education Interim Commissioner, Kevin Dehmer), Gina Trish (designee of Department of Community Affairs Commissioner, Lt. Governor Sheila Y. Oliver), and Steven Ritardi, Esq. (Public Member)
