1. 2.	I will annually submit a provider profile representing populations served by my practice/facility. I will submit more frequently if (1) the number of adults served changes or (2) the status of the facility changes during the calendar year. I will screen patients and document eligibility status at each immunization encounter for 317-Funded Adult (317) Program eligibility	<ol> <li>I will distribute the current Vaccine Information Statements (VIS) each time a vaccine is administered and maintain records in accordance with the National Childhood Vaccine Injury Act (NCVIA), which includes reporting clinically significant adverse events to the Vaccine Adverse Event Reporting System (VAERS).</li> <li>I will comply with the requirements for vaccine management,</li> </ol>

I will maintain all records related to the 317 Program for a minimum of three years and, upon request, make these records available for review. 317 records include, but are not limited to, screening and eligibility documentation, billing records, medical records that verify receipt of vaccine, vaccine ordering records, and vaccine purchase and accountability records.	<ol> <li>Per N.J.A.C. 8:57-3.16, I understand that all providers administering vaccines to children less than 7 years of age must register as a provider with the New Jersey Immunization Information System (NJIIS) and report vaccinations online within 30 days. Additionally, understand that the 317 Program requires every provider to enter al vaccinations given with 317-funded vaccine, into NJIIS within 30 days of administration (regardless of the age of the patient) and agree to comply with this mandate.</li> </ol>
