




Alcohol Use by Bergen County IDRC Clients Compared with 2003 NJ Household Survey




Frequency of Alcohol Use by Bergen County IDRC Clients Compared with 2003 NJ Household Survey




Number of Alcohol-Related Offenses on DMV Records of Bergen County IDRC Clients



Lifetime Marijuana, Cocaine and Heroin Use by Bergen County IDRC Clients Compared with 2003 NJ Household Survey




