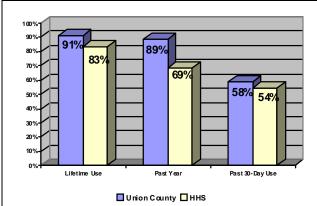

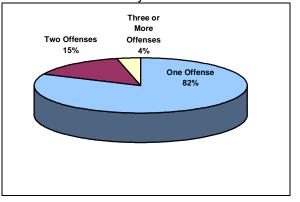

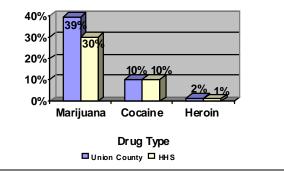
Alcohol Use by Union County IDRC Clients Compared with 2009 NJ Household Survey



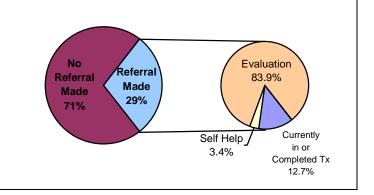
Number of Alcohol-Related Offenses on DMV Records of Union County IDRC Clients

2011 Union County Resident Referrals from IDRC



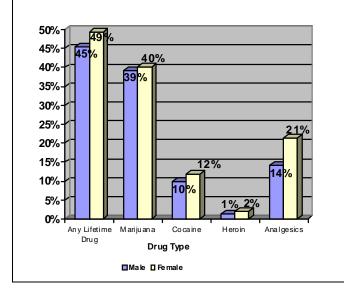
