INTRODUCTION

The Annual Synar Report (ASR) format provides the means for states to comply with the reporting provisions of the Public Health Service Act (42 U.S.C. 300x-26) and the Tobacco Regulation for the Substance Abuse Prevention and Treatment Block Grant (SABG) (45 C.F.R. 96.130 (e)).

How the Synar report helps the Center for Substance Abuse Prevention

In accordance with the tobacco regulations, states are required to provide detailed information on progress made in enforcing youth tobacco access laws (FFY 2019 Compliance Progress) and future plans to ensure compliance with the Synar requirements to reduce youth tobacco access rates (FFY 2020 Intended Use Plan). These data are required by 42 U.S.C. 300x-26 and will be used by the Secretary to evaluate state compliance with the statute. The information to be reported is public (45 CFR 96.130 (f)) and is not confidential. Part of the mission of the Center for Substance Abuse Prevention (CSAP) is to assist states¹ by supporting Synar activities and providing technical assistance helpful in determining the type of enforcement measures and control strategies that are most effective. This information is helpful to CSAP in improving technical assistance resources and expertise on enforcement efforts and tobacco control program support activities, including state Synar program support services, through an enhanced technical assistance program involving conferences and workshops, development of training materials and guidance documents, and onsite technical assistance consultation.

How the Synar report can help states

The information gathered for the Synar report can help states describe and analyze substate needs for program enhancements. These data can also be used to report to the state legislature and other state and local organizations on progress made to date in enforcing youth tobacco access laws when aggregated statistical data from state Synar reports can demonstrate to the Secretary the national progress in reducing youth tobacco access problems. This information will also provide Congress with a better understanding of state progress in implementing Synar, including state difficulties and successes in enforcing retailer compliance with youth tobacco access laws.

¹The term "state" is used to refer to all the states and territories required to comply with Synar as part of the Substance Abuse Prevention and Treatment Block Grant Program requirements (42 U.S.C. 300x-64 and 45 C.F.R. 96.121).

The ASR must be received by SAMHSA no later than December 31, 2019 and must be submitted in the format specified by these instructions. Use of the approved format will avoid delays in the review and approval process. The chief executive officer (or an authorized designee) of the applicant organization must sign page one of the ASR certifying that the state has complied with all reporting requirements.

The state must upload one copy of the ASR using the online WebBGAS (Block Grant Application System). In addition, the following items must be uploaded to WebBGAS:

- FFY 2020 Synar Survey Results: States that use the Synar Survey Estimation System (SSES) must upload one copy of SSES Tables 1-8 (in Excel) to WebBGAS. Please note that, beginning with the FFY 2019 ASR, SSES will generate Tables 6, 7, and 8, which are based on the optional microdata on product type, retail outlet type, and whether identification was requested. If your state does not submit these optional data, Tables 6, 7, and 8 will be blank. Tables 6, 7, and 8 are generated for the convenience of the state, and states are not required to submit completed versions of Tables 6, 7, or 8. Merchant education and/or training

Adult inspectors conduct merchant education training and distribute merchant education materials to retailers at the end of the inspection process.

The STOMP Out Youth Tobacco Use campaign was created to increase merchant education on age of sale requirements and help decrease youth access to tobacco products and exposure to tobacco. The program provides merchant education, the STOMP OUT youth tobacco use sticker and merchant pledge to retailers across the state. STOMP stands for Stop Tobacco Offenses Merchant Program. By implementing the STOMP OUT campaign into the tobacco merchant community, the intent is to spread the word of the new age of sale (21 years and older) and help merchants show that they care about the youth of their communities.

Incentives for merchants who are in compliance (e.g., nonenforcement compliance checks in which compliant retailers are given positive reinforcement and noncompliant retailers are warned about youth access laws)

Community education regarding youth access laws

Through funding from the NJDOH/OTC, Tobacco Free for a Healthy NJ (TFHNJ) has been tasked with conducting tobacco retailer audits to help communities better understand the availability of tobacco products and the tobacco advertising landscape. These audits allow TFHNJ communities to collect data that will help inform policy makers of the dangers of tobacco, specifically youth access and availability and exposure to tobacco marketing. The retail environment is an important area of focus for tobacco control efforts as this is one of the last frontiers for tobacco marketing.

1. OTC continues to conduct the FDA Compliance Check Inspection Program in combination with Synar inspections, (6,317 FDA inspections (Oct 1, 2018 - Sept 30, 2019) and 431 TASE inspections for a total 6,748) which will enhance the number of retailers inspected statewide, which in turn should reduce the overall retail violation rate.

2. Advocates are continuing to educate key stakeholders regarding sustainability messaging to increase activities aimed at enhancing and supporting law enforcement and prevention efforts for the OTC.

3. OTC and DHS/DMHAS have established discussions to enhance efforts to reduce the retail violation rate for Synar.

4.Point of Sale - This project aims to characterize tobacco advertising and product availability in retail locations. Monitoring this type of marketing may highlight youth exposure to different types of tobacco products and indicate how exposure may vary among the sample of New Jersey communities. Additionally, ongoing surveillance of point of sale tobacco marketing may inform future legislation restricting this activity.

 \boxtimes a. Limited resources for law enforcement of youth access laws

NJ SFY 2019 the State of New Jersey legislators have expanded services to residents by dedicating at least 1% of the state's cigarette and tobacco tax revenue to tobacco control and prevention programs. OTC is in the planning stage for increasing the number of TASE program retailer inspections in municipalities with high retailer violation rates and retailers which are near schools. The Office of Tobacco Control (OTC) continues to be placed under the Community Health and Wellness Unit. This office manages the funds from the Center for Disease Control and FDA cost reimbursement contract as well as the Tobacco Age of Sale

(TASE) program. Starting in NJ SFY 2011, the TASE program only conducts the mandated federal inspections.

Due to limiting funding, merchant education training, promotional and educational activities were provided by inspectors to the merchants at the time of inspections.

The Department of the Treasury (Treasury) produces the retailer's list with limited staff to verify accuracy. OTC and DHS/DMHAS will continue to seek collaboration with Treasury to strategically plan a solution to increase the fidelity of the retailers list.

OTC requires adult inspectors to hire youth inspectors. Inspectors have noted that difficulties in recruiting youth inspectors are due to the following:

1. Competition from other youth job opportunities.

2.Parental concerns regarding the safety of the youth conducting inspections.

3. Youth participation in sports and other extra-curricular activities.

OTC has implemented a system to ensure a proper gender balance for youth inspectors. The gender ratio varies for youth inspectors due to following:

1.Competition from other youth job opportunities.

- 2. Youth participation in sports and other extra-curricular activities.
- 3. Inspectors inability to hire youth.
- 4. Youth unavailable due to vacation.



NJDOH/TASE program recruited and hired part-time adult inspectors under Special Services contracts (Public Health Representatives). These employees perform inspections in all areas of the State and recruit youth inspectors (hired by NJDOH as student associates) from schools, community centers and faith-based organizations.

The TASE adult inspectors are trained by the OTC Program Coordinator and/or veteran inspectors. The training includes a protocol and procedures manual developed by NJDOH/TASE. This training manual, The New Jersey Guidelines for Prohibiting the Sale of Tobacco Products to Minors, was developed in June of 1996 and revised in 2003, 2005, 2012 and again in 2016 to ensure standardization in performing inspections. Chapter 3, entitled Compliant Check Inspections Protocol, provides specific training information on how to conduct proper inspections.

The part-time adult TASE inspectors are trained and updated on TASE protocols. Adult TASE inspectors train the youth inspectors, utilizing the training manuals noted above.

The part-time adult TASE inspectors are trained and updated on TASE protocols. Adult TASE inspectors train the youth inspectors, utilizing the training manual and role playing typical inspections. Youth inspectors shadow and observe veteran youth inspectors until they are comfortable in conducting inspections. The youth inspectors are recruited from schools, churches, referrals from youth inspectors, and other youth organizations.

New Jersey requires that a current dated photograph of each youth inspector be kept on file with a copy of his or her birth certificate and signed parental consent. The safety of the youth inspector is paramount always. The TASE manual describes and defines protocols if either the youth inspector or adult supervisor perceive or suspect a possible threat, danger or harm, the adult supervisor is authorized to postpone or cancel the inspection.

The adult inspector transports youth to and from the sites and accompanies them during the attempted buy, particularly when the site is large enough for the adult supervisor to remain inconspicuous. On occasion, based on the discretion of the adult inspectors, the youth inspector may enter the site alone, when a site is so small (e.g. newsstands, kiosk) that suspicion of the clerk would be aroused by the presence of both the adult supervisor and the youth inspector. In all situations, youth inspectors stay within view of the adult supervisor (safety is the primary concern).

The age of hired youth inspectors is currently ages 16-17 years old. New Jersey's law (NJSA 2A:170-51.4) prohibits the sale of any tobacco products to any persons under 19 years old. (21 years old effective November 1, 2017) SAMHSA has made all states aware that the hiring of 15-year-old youth for undercover buys maybe restricted or prohibited by the Fair Labor Standards Act of 1938 (FLSA). TASE has eliminated the use of 15-year-old youth inspectors. Youth inspectors are between the ages of 16 and 17 years old.

Adult inspectors are employed by TASE and are compensated monetarily. Youth inspectors employed by TASE are compensated monetarily.

New inspectors are trained by veteran inspectors and/or the TASE coordinator. Youth are trained by veteran youth and the inspector.
