DHS Fills Key Leadership Positions

Commissioner Jennifer Velez filled several key vacancies in her top management team this week. Among them: an Assistant Commissioner and Deputy Director of the Division of Mental Health and Addiction Services (DMHAS), a Medical Director at the Division of Medical Assistance and Health Services (DMAHS) and Director of the Division of Disability Services (DDS). Other critical positions including: Assistant Directors in three Divisions, a Chief Information Officer in Medicaid and a Director in the Office of Legal and Regulatory Affairs. Medicaid Managed Care Carve-In

Medicaid clients not yet enrolled in a managed care plan must do so by July 18. 'Ready to Enroll' packets describing the four HMOs contracted with Medicaid and their respective insurance plans have all been mailed. To help providers and consumers navigate the change, DHS has created a dedicated web page about the <u>Medicaid Managed Care</u> carve-in. This page will be updated regularly, and as necessary, with FAQs, enrollment information and deadlines.

Self-Help Centers Prepare Mental Health Consumers for Independent Living

<u>Self-Help Centers</u> have opened on the grounds of Greystone Park and Trenton Psychiatric Hospitals. The centers will provide peer support and link consumers to community wellness and employment services as they pursue recovery outside of the hospital. Special Needs Housing Partnership

The Department of Community Affairs and DHS hosted an information session this week for agencies and developers interested in responding to the <u>RFQ</u> to create affordable, supportive housing for 600 people with developmental disabilities by June 2013. About **75** companies and community providers attended the successful two-hour session.
