FINAL DECISION

AGENCY DKT. NO. GA125860 (ESSEX COUNTY DIVISION OF WELFARE)

Petitioner appeals from the Respondent Agency's denial of his continued Work First New Jersey/General Assistance ("WFNJ/GA") cash benefits. The Agency denied Petitioner continued WFNJ/GA benefits because it determined that he failed to reapply for said benefits. Because Petitioner appealed, the matter was transmitted to the Office of Administrative Law for a hearing. On December 22, 2015, the Honorable Jesse H. Strauss, Administrative Law Judge ("ALJ"), held a plenary hearing, took testimony and admitted documents.

On December 22, 2015, the ALJ issued an Initial Decision, reversing the Agency's determination. The record shows that Petitioner received WFNJ/GA cash benefits and was medically deferred from work activities. See Initial Decision at 2. The record also shows that at the time of Petitioner's redetermination for continuation of WFNJ/GA benefits, he submitted an updated MED-1 form, as requested by the Agency. Ibid. Additionally, the record shows that the Agency did not notify Petitioner that he was required to execute a new application, in addition to submitting an updated MED-1 form. Ibid. The ALJ found that the Agency had failed to assist Petitioner in the redetermination process. Ibid; see also N.J.A.C. 10:90-3.22(b). The ALJ also found, and the Agency admitted, that Petitioner had met all the WFNJ/GA eligibility requirements for a continuation of said benefits. See Initial Decision at 2. Accordingly, the ALJ concluded, and I agree, that the Agency improperly denied Petitioner a continuation of his WFNJ/GA cash benefits. Id. at 3.

No Exceptions to the Initial Decision were filed.
