



## **MONOPOLY MILLIONAIRES' CLUB** **DRAW GAME SUSPENDED** **AS OF DECEMBER 26, 2014**

#### **QUESTIONS & ANSWERS**

##### ***What's Happening?***

- Sales in the **MONOPOLY MILLIONAIRES' CLUB Draw Game** in its current format will end at 10:15 p.m. on December 26, 2014.

##### ***Why Is The Game Being Suspended?***

- The weekly **MONOPOLY MILLIONAIRES' CLUB Draw Game** was not as popular with players as anticipated. Sales of the game have run below industry projections since its October 19, 2014 debut across the country.
- Prizes are paid from the revenue generated from ticket sales. New Jersey had the game's first and only Top Prize winner claiming a cash prize valued at more than \$12 million. That prize and all other lower tier prizes have been paid. All additional claimed prizes will be paid for up to one year from the date of the initial drawing.
- Ticket sales revenue will also be used to fulfill the TV show contestant prizes including airfare, hotel and spending money.
- TV show production costs will be paid by sales revenue.
- At the end of the game, after all prizes and expenses have been paid, any remaining funds will be returned to the New Jersey Lottery and directed to the unclaimed prize fund as per the New Jersey Administrative Code, Title 17, Chapter 20, Section 7.6 which states that:  
Upon the conclusion of any specific game, when the prize allocation is in excess of the allocation necessary to sustain the payment of prizes within the prize pool, such excess shall be allocated as unclaimed prize money pursuant to N.J.S.S. 5:9-17.

##### ***What Do Players Need To Know?***

- Tickets of the **MONOPOLY MILLIONAIRES' CLUB Draw Game** will continue to be sold until 10:15 p.m. on December 26, 2014; the final game drawing will be held at 11:15 p.m. Players who purchase tickets prior to the game suspension on Friday, December 26, will still have one year following the drawing to claim any prizes won.

##### ***What Happens If I Win a Prize?***

- All prizes won through the final drawing will be honored in full.

***How Does This Change the Opportunity to be A Contestant on the Game Show?***

- Contestants already selected for the game show will be traveling to Las Vegas in January and will attend the tapings as planned.
- All entries into the **MONOPOLY MILLIONAIRES' CLUB** TV show drawing will be eligible for the Jan. 13 drawing for the trips to Las Vegas. The TV show will be taped as advertised.

***What Happens To The Web Codes Entered For The Game Show?***

- The next 2<sup>nd</sup> Chance drawing for game-show trip winners will proceed as scheduled on January 13, 2015. Any web codes entered for that drawing are still valid. The deadline to enter the next TV game show drawing is January 6, 2015, and the drawing to determine trip winners takes place a week later as scheduled. The players who win those trips are scheduled to travel February 19-23, 2015 to Las Vegas.

***What Happens To The Partial Property Sets?***

- The Lottery Directors will be meeting in early January to determine whether the game will be relaunched in a new format. The partial property sets will remain available for potential use in the revised game.

***Will This Affect The MONOPOLY INSTANT GAME Family That Began On September 2nd?***

- No, this will not affect the distribution or sales of the MONOPOLY Instant Game family that began on September 2, 2014.
