Dear Nurse Colleague:

As you are aware, the Board of Nursing is required by statute to be self-supporting, as are all the professional licensing boards within the Division of Consumer Affairs. It is mandated that fees should be established to the extent necessary to defray all operating costs of the board but not fixed at a level that will raise amounts in excess of the amount estimated to be required (N.J.S.A. 45:1-3). In light of this mandate, the Board of Nursing has voted to propose increases to licensing fees twice since the last adopted increase in February 1999. The Board approved an increase in 2000 which was not authorized for proposal in the New Jersey Register and was not adopted. The second Board-approved increase was published November 7, 2005 at 37 N.J.R. 4179 (a). This increase has been authorized by the Governor and is due to be published as an adopted rule in the New Jersey Register on March 20, 2006.

Please be aware that the increased renewal fees will affect those licensees/certificants with an expiration date of May 31, 2006.

All other fees will be imposed beginning March 20, 2006 upon their publication in the New Jersey Register.

*Homemaker- Home Health Aides are certified on a biennial basis. Their next expiration date is November 30, 2007.

**Massage, Bodywork, Somatic Therapists are also certified on a biennial basis. Their next expiration date is November 30, 2006.
