CCC Announces April Casino Revenue

ATLANTIC CITY— Casinos reported \$313.6 million in casino win in April, a 14.2 percent decrease over the same month a year ago.

Results reported to the New Jersey Casino Control Commission Monday show that the 11 casinos won \$220.6 million at the slot machines and another \$92.9 million at table games in April. Slot revenue fell 14.9 percent while table game revenues decreased by 12.5 percent. After adjustments and a deduction for promotional gaming credits, casinos paid \$24.7 million on taxable gross revenue of \$308.3 million in April. That money, 8 percent of taxable gross revenue, goes into the Casino Revenue Fund which pays for programs that benefit qualifying senior citizens and people with disabilities. In addition, the casinos incurred another \$3.9 million in reinvestment obligations. They are required to reinvest 1.25 percent of taxable gross revenues in projects approved by the Casino Reinvestment Development Authority.

For the first four months of the year, casinos won \$1.3 billion, down 15.7 percent from the same period in 2008. Revenue from slot machines is down 16.5 percent and revenue from table games is down 14 percent for the four months.

Win, or casino revenue, is the net amount of money won by casinos. It is not profit.
