ATLANTIC CITY— Casinos reported \$335.4 million in casino win in September, a 5.8 percent decrease over the same month a year ago.

Results reported to the New Jersey Casino Control Commission Monday show that the 11 casinos won \$231.8 million at the slot machines and another \$103.5 million at table games in September. Slot revenue was down 5.2 percent while table revenues decreased 6.9 percent. Casinos paid \$23.9 million in taxes on their gross revenues in September. That money, 8 percent of gross revenue, goes into the Casino Revenue Fund which pays for programs that benefit qualifying senior citizens and people with disabilities. In addition, the casinos incurred another \$4.2 million in reinvestment obligations. They are required to reinvest 1.25 percent of gross revenues in projects approved by the Casino Reinvestment Development Authority.

For the first nine months of the year, casinos won \$3.0 billion, down 14.2 percent from the same period in 2008. Revenue from slot machines is down 14.2 percent and revenue from table games is down 14.1 percent for the seven months.

Win, or casino revenue, is the net amount of money won by casinos. It is not profit.
