ATLANTIC CITY – The 11 casinos here reported a 22.6 percent decline in gross operating profits in the second quarter of 2010, according to figures released Wednesday by the New Jersey Casino Control Commission.

Gross operating profits for the 11 properties totaled \$149 million for the threemonth period compared to \$192.5 million for the same 11 casinos in the second quarter of 2009. Net revenues fell by 5.5 percent for the period to \$922 million.

Borgata led the industry with \$44.5 million in gross operating profits, but that was down 10.5 percent from the same period last year. Harrah's reported gross operating profits of \$34 million for the quarter. That represents a 13.5 percent decline over the same period a year ago.

Bally's reported \$23.6 million in gross operating profits, a 14.4 percent decline, while Caesars reported a 43.2 percent decline to \$18.7 million. Trump Taj Mahal earned \$13.9 million in gross operating profits, down 4 percent, and Showboat earned \$13.6 million, a decline of 24 percent. Tropicana reported a 0.8 percent increase in gross operating profits to \$9.3 million and Trump Plaza reported a 32.1 percent decrease to \$2.5 million.

Trump Marina reported a gross operating loss of \$1.1 million compared to a gross operating profit of \$2.2 million in the same period a year ago. Resorts reported a gross operating loss of \$3.8 million compared to a \$3.9 million loss

last year. The Atlantic City Hilton had a gross operating loss of \$6.3 million compared to a loss in the same quarter last year of \$603,000.

Gross operating profit represents earnings before interest, taxes, depreciation, amortization and charges from affiliates. After all of those other charges, the industry reported a net loss of \$15.7 million for the three-month period compared to a loss of \$577.3 million last year.

The number of occupied room nights increased by 0.5 percent compared to the same quarter last year and the overall occupancy rate increased to 85.2 percent versus 84.6 percent.

For the first half of the year, gross operating profits for the 11 casinos were down 23 percent to \$262.7 million and net revenues were down 6.7 percent to \$1.77 billion. Casinos reported a net loss of \$83.2 million for the first half of this year compared to \$668.9 million in the first half of last year.
