## **DGE Announces November 2013 Casino Win Results**

ATLANTIC CITY —

Based upon filings with the Division of Gaming Enforcement, total casino win was \$224.7 million in November 2013 compared to \$176.6 million last November. The 27.2% increase was impacted by Hurricane Sandy in November 2012 and an extra Saturday in November 2013. Table game win was \$60.3 million, reflecting an increase of 19.5% compared to the prior period. Slot machine win was \$164.4 million, reflecting an increase of 30.3%.

Casinos incurred \$15.7 million in taxes on their gross revenues in November. That money, 8 percent of taxable gross revenue, goes into the Casino Revenue Fund, which pays for programs that benefit qualifying senior citizens and people with disabilities. In addition, the casino industry incurred \$2.8 million in reinvestment obligations based on their gross revenues for the month. Casinos are required to reinvest 1.25 percent of gross revenues in projects approved by the Casino Reinvestment Development Authority.

For the first eleven months of the year, casinos won \$2.7 billion, reflecting a decrease of 6.1% from the same period last year.

Win reflects the net amount of money won by casinos. It is not profit.
