DGE Announces April 2014 Gaming Revenue Results

ATLANTIC CITY —

Based upon filings with the Division of Gaming Enforcement, casino win from the eleven casino hotels open in both April 2013 and 2014 (excluding Atlantic Club) increased by 3.3%. Six casino hotels reported an increase in casino win for April 2014, four of which were up between 12% and 55% compared to April 2013. Including Atlantic Club, casino win declined 1.8% compared to April of last year.

Internet gaming win was \$11.4 million for the 30 days in April, compared to \$11.9 million for the 31 days in March 2014. Internet gaming win per day was relatively flat at \$380,958 for April 2014 and \$383,173 for March 2014. Internet gaming win for April consisted of \$2.6 million in Peer-to-Peer win and \$8.8 million in Other Authorized Games. As of April 30, 2014, 322,423 Internet gaming accounts have been created, up 10.6% from the 291,625 accounts as of March 31, 2014.

Total gaming win from the casino hotels and Internet gaming operations was \$235.9 million in April 2014, a 3.2% increase compared to the \$228.5 million in casino win for April 2013 (including Atlantic Club).

Casinos incurred \$18 million in total gaming taxes in April 2014 reflecting an increase of 8.8% compared to April 2013. For the four months ended April 2014, casinos incurred \$66.2 million in total gaming taxes, up 2.9% compared to last year. Total gaming taxes reflect 8% of taxable casino gross revenue and 15% of Internet gaming gross revenue. In addition, the casino industry incurred \$3.1 million in reinvestment obligations with the Casino Reinvestment Development Authority for April, which reflects 1.25% of casino gross revenue and 2.5% of Internet gaming gross revenue.
