and other persons whose identities are known and unknown to the Grand Jurors, who are named as co-conspirators and members of the criminal enterprise, but not defendants herein, at the times and places hereinafter specified, did commit the crime of racketeering, that is, the defendants and other persons employed by or associated with the enterprise engaged in activities which affected trade or commerce in the State of New Jersey, in that they:

1. Purposely or knowingly did conduct or participate directly or indirectly in the conduct of the enterprise's affairs through a pattern of racketeering activity, including the

commission of crimes of the first degree, contrary to the provisions of N.J.S.A. 2C:41-2c; or

2. With the purpose of promoting or facilitating the commission of the crime of racketeering, did conspire or agree together and with persons whose identities are known to the Grand Jurors, who at times relevant to this indictment were acting at the direction of the New Jersey Division of Criminal Justice, and with persons who were members of the New Jersey Division of Criminal Justice and other law enforcement agencies and were acting in an undercover capacity, that:

A. One or more of them would engage in conduct which would constitute the crime of racketeering; or

B. One or more of them would aid in the planning, solicitation or commission of the crime of racketeering, that is, to conduct or participate, directly or indirectly, in the conduct of the enterprise's affairs through a pattern of racketeering activity, including the commission of crimes of the first degree, in violation of N.J.S.A. 2C:41-2d, all as hereinafter described.

The Relevant Times and Places

The predicate criminal activity and conspiracy occurred between on or about March 15, 2011 and May 30, 2012, at the City of Camden, at the Township of Cherry Hill, at the Borough of Merchantville, at the Borough of Audubon, at the Township of Haddon, all in the County of Camden; at the City of Philadelphia, in the County of Philadelphia, in the Commonwealth of

Pennsylvania; in the Commonwealth of Puerto Rico; elsewhere, and within the jurisdiction of this Court.

The Enterprise

NOEL GONZALEZ, MICHAEL RIVERA, VICENTE PORRATA, LUIS RODRIGUEZ, LUZ RIPOLL, VIRGILIO VARGAS, JR., GREGORIO LABOY, JR., WILLIAM ALVAREZ, ANGEL MARTINEZ, JOSEPH RIVERA, SAMUEL SERRANO, FRED ALVARADO, JONATHAN SANTIAGO, WILKINS CASTRO, CINDY SCANES, JONATHAN ROMAN, JESSMARIE RAMIREZ, MICHAEL ORTIZ, EDUARDO ORTIZ, CHRISTOPHER VASQUEZ, GEORGE RIVERA, GIOVANNI MERCADO, MIGUEL BELLO, VICTORIA VENTURA, TIMOTHY PETERS, LUIS VAZQUEZ, WILLIAM RIVERA, HASSAN TORRES, JOSE O. DIAZ, JULIO MEDINA, VICTOR SERRANO, JUAN SANTANA, CALVIN LEWIS, SEBASTIAN CORDERO, JONATHAN VASQUEZ, and DEWAYNE SHINES, and other persons whose identities are known and unknown to the State and are members of this enterprise although not charged herein, did constitute an enterprise within the meaning of N.J.S.A. 2C:41-1c, that is, a group of individuals associated in fact for the purpose set forth below.

The Purposes of the Enterprise

The purposes of the enterprise would include the unlawful distribution of controlled dangerous substances in exchange for United States currency to perpetuate the enterprise, accomplished as follows: The enterprise had a leadership which supervised and managed subordinate members in a common course of conduct to distribute and transport, within and without this State,

controlled dangerous substances, including, but not limited to heroin and cocaine. The enterprise consisted of co-leaders who obtained the controlled dangerous substances from their supplier(s). The co-leaders then coordinated the distribution of controlled dangerous substances to middle managers, known as "case workers" or "runners." The middle managers would then coordinate the distribution of controlled dangerous substances to the street level managers and dealers, known as "set managers" and "trappers" respectively. Upon selling the controlled dangerous substances, the case workers, set managers, and trappers were permitted to keep a portion of the proceeds as determined by their role and returned the remaining profits to the co-leaders. The case workers and co-leaders would also sell controlled dangerous substances to wholesale clients who purchased larger quantities than that which was typically purchased from the street level distributors.

#### The Pattern of Racketeering Activity

The pattern of racketeering activity, as defined in N.J.S.A. 2C:41-1d, consisted of at least two incidents of racketeering conduct by members of the enterprise, including, but not limited to: Leader of Narcotics Distribution Network (N.J.S.A. 2C:35-3); Possession With Intent to Distribute a Controlled Dangerous Substance (N.J.S.A. 2C:35-5, et seq.); Distribution of a Controlled Dangerous Substance (N.J.S.A. 2C:35-5, et seq.); Distribution of a Controlled Dangerous Substance on or Near



School Property (N.J.S.A. 2C:35-7); Distribution of a Controlled Dangerous Substance Within 500 Feet of Certain Public Property (N.J.S.A. 2C:35-7.1); Financial Facilitation of Criminal Activity (N.J.S.A. 2C:21-24, et seq.); Unlawful Purchase, Transfer, or Use of Firearms; and Conspiracy to commit the foregoing crimes (N.J.S.A. 2C:5-2) as described herein.

NOEL GONZALEZ

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Leader of Narcotics Trafficking Network, Conspiracy, Financial Facilitation of Criminal Activity, Distribution of a Controlled Dangerous Substance, Distribution of a Controlled Dangerous Substance Within 500 Feet of Certain Public Property, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Two, Three, Four, Six, Nine and Ten of this indictment, as well as prior conduct.

MICHAEL RIVERA

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Leader of Narcotics Trafficking Network, Conspiracy, and Financial Facilitation of Criminal Activity, Unlawful Purchase, Transfer, or Use of Firearms, which is the subject of Counts Two, Three, Six, Seven, and Eight of this indictment, as well as prior conduct.

VICENTE PORRATA

did commit the racketeering conduct by engaging in or conspiring

to commit repeated acts of Conspiracy, Possession of a Controlled Dangerous Substance With Intent to Distribute, and Financial Facilitation of Criminal Activity, which is the subject of Counts Three, Five, and Six of this indictment, as well as prior conduct.

LUIS RODRIGUEZ

did commit the racketeering conduct by engaging in repeated acts of Conspiracy to commit Unlawful Purchase, Transfer, or Use of Firearms, which is the subject of Count Three of this indictment, as well as prior conduct.

LUZ RIPOLL

did commit the racketeering conduct by engaging in repeated acts of Conspiracy to commit Distribution of a Controlled Dangerous Substance, which is the subject of Count Three of this indictment, as well as prior conduct.

VIRGILIO VARGAS, JR.

did commit the racketeering conduct by engaging in repeated acts of Conspiracy to commit Distribution of a Controlled Dangerous Substance, which is the subject of Count Three of this indictment, as well as prior conduct.

GREGORIO LABOY, JR.

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Distribution of a Controlled Dangerous Substance, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the

subject of Counts Three, Four, and Eleven of this indictment, as well as prior conduct.

WILLIAM ALVAREZ

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Possession of a Controlled Dangerous Substance With Intent to Distribute, and Possession of a Controlled Dangerous Substance With Intent to Distribute On or Near School Property, which is the subject of Counts Three, Five, and Twelve of this indictment, as well as prior conduct.

ANGEL MARTINEZ

did commit the racketeering conduct by engaging in repeated acts of Conspiracy to commit Distribution of a Controlled Dangerous Substance, which is the subject of Count Three of this indictment, as well as prior conduct.

JOSEPH RIVERA

did commit the racketeering conduct by engaging in repeated acts of Conspiracy to commit Distribution of a Controlled Dangerous Substance, which is the subject of Count Three of this indictment, as well as prior conduct.

SAMUEL SERRANO

did commit the racketeering conduct by engaging in repeated acts of Conspiracy to commit Distribution of a Controlled Dangerous Substance, which is the subject of Count Three of this indictment, as well as prior conduct.

FRED ALVARADO

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Distribution of a Controlled Dangerous Substance, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, and Thirteen of this indictment, as well as prior conduct.

JONATHAN SANTIAGO

JESSMARIE RAMIREZ

MIGUEL BELLO

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Distribution of a Controlled Dangerous Substance, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, and Twenty-Five of this indictment, as well as prior conduct.

VICTORIA VENTURA

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy and Distribution of a Controlled Dangerous Substance on or Near School Property, all of which is the subject of Count Three of this indictment, as well as prior conduct.

TIMOTHY PETERS

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Distribution of a Controlled Dangerous Substance, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, and Twenty-Six of this indictment, as well as prior conduct.

LUIS VAZQUEZ

did commit the racketeering conduct by engaging in or conspiring

to commit repeated acts of Conspiracy, Distribution of a Controlled Dangerous Substance, Distribution of a Controlled Dangerous Substance Within 500 Feet of Certain Public Property, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, Twenty-Seven, and Twenty-Eight of this indictment, as well as prior conduct.

WILLIAM RIVERA

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Distribution of a Controlled Dangerous Substance, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, and Twenty-Nine of this indictment, as well as prior conduct.

Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, and Thirty-One of this indictment, as well as prior conduct.

JULIO MEDINA

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Distribution of a Controlled Dangerous Substance, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, and Thirty-Two of this indictment, as well as prior conduct.

VICTOR SERRANO

did commit the racketeering conduct by engaging in repeated acts of Conspiracy to commit Distribution of a Controlled Dangerous Substance, which is the subject of Count Three of this indictment, as well as prior conduct.

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Distribution of a Controlled Dangerous Substance, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, and Thirty-Three of this indictment, as well as prior conduct.

CALVIN LEWIS

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Distribution of a

Controlled Dangerous Substance, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, Thirty-Four, and Thirty-Five of this indictment, as well as prior conduct.

SEBASTIAN CORDERO

did commit the racketeering conduct by engaging in or conspiring to commit repeated acts of Conspiracy, Distribution of a Controlled Dangerous Substance, Distribution of a Controlled Dangerous Substance Within 500 Feet of Certain Public Property, and Distribution of a Controlled Dangerous Substance on or Near School Property, which is the subject of Counts Three, Four, Thirty-Six, and Thirty-Seven of this indictment, as well as prior conduct.

Controlled Dangerous Substance, Possession with the Intent to Distribute a Controlled Dangerous Substance, Possession with the Intent to Distribute a Controlled Dangerous Substance within 1,000 feet of School Property, Possession with the Intent to Distribute a Controlled Dangerous Substance within 500 feet of Public Property, Unlawful Transfer of a Firearm, and Unlawful Possession of a Handgun, did agree together and with persons whose identities are known to the Grand Jurors, who at all times relevant to this Indictment were sworn law enforcement officers acting in an undercover capacity or were cooperating witnesses acting under the direction of the New Jersey Division of Criminal Justice and/or other law enforcement agencies, that:

A. One or more of them would engage in conduct which would constitute the aforesaid crimes, or

B. One or more of them would aid in the planning, solicitation or commission of said crimes, that is:

1. Knowingly or purposely to commit the offense of Financial Facilitation of Criminal Activity, contrary to the provisions of N.J.S.A. 2C:21-24, et seq.

2. Knowingly or purposely to distribute a controlled dangerous substance, that is, heroin and/or cocaine, in a quantity of five ounces or more, contrary to the provisions of N.J.S.A. 2C:35-5a(1), N.J.S.A. 2C:35-5b(1), N.J.S.A. 2C:35-5c, and N.J.S.A. 2C:2-6.

3. Knowingly or purposely to possess with intent to distribute a controlled dangerous substance, that is, heroin

and/or cocaine, in a quantity of five ounces or more, contrary to the provisions of N.J.S.A. 2C:35-5a(1), N.J.S.A. 2C:35-5b(1), N.J.S.A. 2C:35-5c, and N.J.S.A. 2C:2-6.





on or about May 30, 2012, at the City of Camden, in the County of Camden, elsewhere, and within the jurisdiction of this Court, having been previously convicted of the crime of possession with intent to distribute a controlled dangerous substance within 1,000 feet of school property (N.J.S.A. 2C:35-7), on Camden County Indictment Number 06-01-00311-I, did possess or control a weapon, that is, a Desert Eagle .40 caliber semi-automatic handgun, contrary to the provisions of N.J.S.A. 2C:39-7b(1), and against the peace of this State, the government and dignity of the same.
