The New Jersey Racing Commission (hereinafter "Commission"), pursuant to N.J.S.A. 5:5-127 et seq., known as the "Off-Track and Account Wagering Act" (hereinafter "Act"), has the full power to prescribe rules, regulations and conditions under which an off-track wagering license is issued in this State and to revoke, suspend or refuse to renew a license if in the opinion of the Commission the revocation of, suspension of or refusal to renew such license is in the public interest.

Pursuant to the powers vested in it by the Act, the Commission has promulgated regulations governing the conduct of off-track wagering in this State, which appear at N.J.A.C. 13:74 et seq. In accordance with the Act and N.J.A.C. 13:74-2.1(a), the Commission has prescribed the within "off-track wagering license application" to be completed by the New Jersey Sports and Exposition Authority and filed with the Commission for each proposed off-track wagering facility. Upon the filing of this completed application, the Commission shall consider such application pursuant to the procedure set forth in N.J.A.C. 13:74-2.1 in the case of an initial application and pursuant to the procedure set forth in N.J.A.C. 13:74-2.3 in the case of a renewal application.

Any off-track wagering license issued to the Authority shall specify the effective dates of the license, the location of the off-track wagering facility subject of the license, the periods of time during the calendar year and the maximum hours of operation during which off-track wagering is permitted at the facility and such other terms or conditions which may be imposed by the Commission in accordance with the Act and N.J.A.C. 13:74-2.1(m) or 2.3(k), as appropriate.

Pursuant to the Act, the undersigned New Jersey Sports and Exposition Authority (hereinafter "Authority" or "Applicant"), as created by section 4 of P.L. 1971, c.137 (C.5:10-4), hereby makes application for an off-track wagering license, as designated immediately below, to the Commission:
