**Full text** of the adopted amendments follows:

#### SUBCHAPTER 2. AWARD CRITERIA, APPLICATION PROCEDURES, AND ISSUANCE

##### 5A:10-2.1 Criteria for award

(a) (No change.)

(b) Any former resident of this State shall be eligible for the award of the New Jersey Vietnam 25th Anniversary Commemorative Medal upon:

1. Proof of residency in the State of New Jersey on the date of induction into the organized militia or Federal military service;

2. Presentation of a Department of Defense (DD) Form 214 indicating an honorable discharge from any branch of the armed forces of the United States; and

3. A demonstration that the individual was on active duty in any branch of the armed forces of the United States in Vietnam, Thailand, Laos, or Cambodia, or the contiguous waters or air space thereof on or after December 31, 1960, and on or before May 7, 1975, and:

i. Was attached to or served for one or more days with an organization participating in or directly supporting military operations;

ii. Was attached to or served for one or more days aboard a United States Naval vessel directly supporting military operations;

iii. Participated as a crew member in one or more aerial flights into airspace above Vietnam and contiguous waters directly supporting military operations; or

iv. Served on temporary duty for 30 consecutive days or 60 nonconsecutive days in Vietnam or contiguous areas, except that this time

limit may be waived for persons participating in actual combat operations.

##### 5A:10-2.2 Procedures for requesting award

(a) Eligible individuals shall submit a written request for the awarding of the New Jersey Vietnam 25th Anniversary Commemorative Medal along with the documentation specified in N.J.A.C. 5A:10-2.1(a) or (b) to:

(b) The New Jersey Vietnam 25th Anniversary Commemorative Medal for a deceased person may be requested by and shall be issued to a surviving spouse or immediate family member who submits all of the required forms and documentation specified in N.J.A.C. 5A:10-2.1(a) or (b), to include proof of death, such as a copy of a death certificate, newspaper article (obituary), or death notice, coroner's report of death, funeral director's signed statement of death, or verdict of coroner's jury, on behalf of that person to the address listed in (a) above.

##### 5A:10-2.3 Issuance of the award

(a) Upon verification of eligibility for the award, the New Jersey Department of Military and Veterans' Affairs will issue, at no cost to the applicant, the New Jersey Vietnam 25th Anniversary Commemorative Medal with the service ribbon and appropriate certificate.

**Take notice** that pursuant to N.J.S.A. 52:14B-5.1, the Discharges of Petroleum and Other Hazardous Substances (DPHS) rules at N.J.A.C. 7:1E are readopted and shall continue in effect for a seven-year period. The rules had been scheduled to expire on February 27, 2014. The Department of Environmental Protection (Department) has reviewed these rules and has determined that the rules should be readopted because they are necessary, reasonable and proper for the purpose for which they were originally promulgated. In accordance with N.J.S.A. 52:14B-5.1.c(1), timely filing of this notice extended the expiration date of the chapter seven years from the date of filing.

The DPHS rules establish standards for emergency response in the event of a discharge of a hazardous substance, and establish standards for discharge prevention for major facilities storing or handling hazardous substances. The rules contain general provisions for the discharge prevention program, including definitions; standards applicable to storing, transferring, processing, or using hazardous substances and to equipment and procedures utilized at major facilities; registration requirements for transmission pipelines; requirements for the preparation and submission of Discharge Prevention, Containment and
