

## WHAT IS ON-THE-JOB TRAINING?

On-The-Job Training (OJT) is training that you receive while actually performing a job and earning wages. You may be eligible to receive GI Bill benefits while in an OJT program. OJT programs normally run six months to two years in length. Some examples of currently approved OJT programs are: Manager, Short Order Cook, Service Technician, Warehouse Person, Shipping and Receiving Clerk and Metal Fabricator.

## WHAT IS APPRENTICESHIP TRAINING?

Apprenticeship Training is on-the-job training coupled with related theory instruction. You receive your GI Bill benefits while working full time and earning wages. Apprenticeship programs are normally from two years to five years in length. Although program registrations with the New Jersey Department of Education and the U.S. Department of Labor are not mandatory for veterans benefits, they are recommended in order to receive a certificate of completion. Some examples of currently approved apprenticeship programs are: Carpenter, Electrician, Brick Layer, Plumber, Iron Worker, Machinist, Police Officer, Firefighter, Chemical Operator, Tax Auditor, Nuclear Equipment Operator and Maintenance Mechanic.

## WHEN CAN YOU APPLY FOR BENEFITS?

As a general rule, veterans have ten (10) years after their separation from active service to use their GI Bill benefits. The Chapter 34 GI Bill (Vietnam Era) ended on December 31, 1989; however, some Chapter 34 veterans are now eligible for benefits under Chapter 30. Contact the Department of Veterans Affairs to determine your eligibility.

## HOW TO BEGIN

1. If you do not have a job, or if you are not working in the occupation you want, contact your local New Jersey State Job Service Office. The Veterans Employment Representative will assist you to find an employer who can offer the kind of training you need to reach the occupational objective you select.
2. Next, have your employer contact the State Approving Agency so that the necessary steps can be taken to approve the training program. Keep in mind that not all occupations can be approved. Please contact the State Approving Agency for more information.
3. Contact the Department of Veterans Affairs to determine your eligibility and to obtain the necessary application forms.

## MEMBERS OF THE RESERVE/NATIONAL GUARD

Effective October 1, 1990, certain members of the Reserve/National Guard may be eligible for educational assistance allowance for participation in approved on-the-job training and/or apprenticeship training programs. Contact your Reserve/National Guard Unit to verify your eligibility for Chapter 1606 benefits.

## WHAT IS THE AMOUNT OF THE MONTHLY BENEFIT CHECK?

If you are eligible under Chapter 30 (entered active duty after July 1, 1985 and contributed to the Montgomery GI Bill) your monthly allowance should be either:

**For those veterans whose initial obligated period of active duty was three years or more (Rates effective October 1, 2009)**

First 6 months of training	\$1026.00
Second 6 months of training	\$ 752.40
Remainder of training	\$ 478.80

**OR**

**For those veterans whose initial obligated period of active duty was less than three years (Rates effective October 1, 2009)**

First 6 months of training	\$833.25
Second 6 months of training	\$611.05
Remainder of training	\$388.85

**If an individual participated in "specific" programs, they may be eligible for additional amounts ("kickers").**

If you are eligible under Chapter 32 (entered active duty between January 1, 1977 and June 30, 1985) and contributed to the Veterans Educational Assistance Program, your monthly allowance will be determined based upon your contributions. Contact the Department of Veterans Affairs for information on your specific allowance.

If you were eligible under Chapter 34 (entered active duty between February 1, 1955 and December 31, 1976), you may be eligible to receive benefits under the Chapter 30 program. Contact the Department of Veterans Affairs for more specific information.

**If you are eligible under Chapter 35 (a surviving spouse or dependent) your monthly allowance should be: (Rates effective October 1, 2009)**

First 6 months of training	\$674.00
Second 6 months of training	\$505.00
Third 6 months of training	\$333.00
Remainder of training	\$168.00

**If you are eligible under Chapter 1606 (National Guard or Reserve member) your monthly allowance should be: (Rates effective October 1, 2009)**

First 6 months of training	\$249.75
Second 6 months of training	\$183.15
Remainder of training	\$116.55

**If you are eligible under Chapter 1607 (a member of a Reserve component who served on active duty on or after September 11, 2001 under title 10, US Code for at least 90 consecutive days under a contingency operation or a**

National Guard member whose service extended for 90 consecutive days or more and your service is authorized under section 502(f) title 32, US Code, is authorized by the President or Secretary of Defense for a national emergency and is supported by federal funds) your monthly entitlement should be: (Rates effective October 1, 2009)

Remainder of training	\$191.52	\$287.28	\$383.04
