Season's Greetings



Friends and Fellow Veterans,

I'd like to take this opportunity to thank you for the great support you have given the NJ Department of Military and Veterans Affairs. The pace over the past six weeks has been especially demanding; whether it was troop departures, Welcome Home Ceremonies or Veterans Day, you have been there to support us. Thank You!

Once again, we need the help of each and every Veteran activist in spreading the word about our latest initiative, **The Veterans Outreach Program**. Featured on the cover of this issue, we are undertaking this effort for two distinct reasons: to educate more of our veterans on benefits and to address issues raised in a series of recently released federal reports.

First, as I travel the state and talk with Veterans, it is surprising how many are not aware of the programs and services this Department provides to them and their families. The Outreach Program is designed to bring that message to as many people as possible, by staffing an informational display in heavily trafficked locations. You can help by spreading that word as well, anytime

you meet and speak with another Veteran.

Second, a series of recently released reports stated that New Jersey's Veterans receive less compensation from the U.S. Department of Veterans Affairs than Veterans in other states; a statement that is misleading. A New Jersey Veteran, with a specific, service-connected disability, receives exactly the same amount of compensation from the VA that a Veteran in any other state with the same disability. What does vary is the **average compensation** that our Veterans receive and New Jersey's is lower than the national average.

There are a number of demographic factors that influence this which are completely out of our control but, while we cannot change the average compensation, we can influence the number of claims submitted by our state. Nationally, ten percent of all Veterans receive some form of compensation from the VA for a service-connected disability. Of New Jersey's 600,000 Veterans, only eight percent receive such benefits. **This means that 12,000 NJ Veterans who could be receiving benefits are not!** Through the Veterans Outreach Program, we hope to find these individuals and assist them in filing the claims they are entitled to.

We at the Department of Military and Veterans Affairs will be working hard to ensure that **all** of New Jersey's Veterans know what their state and federal benefits are. To find out more about the program or your Veteran benefits, call **1-888-8NJ-VETS**.


My job has been a little scary at times over the past year. However, when I think about the sacrifices made by our men and women in uniform, it puts everything in perspective.

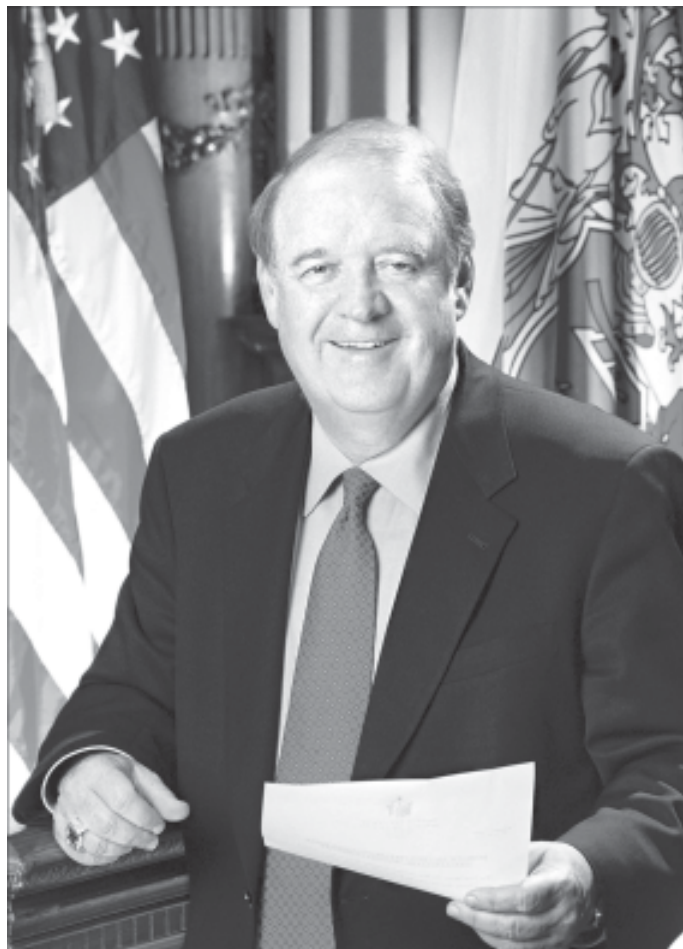

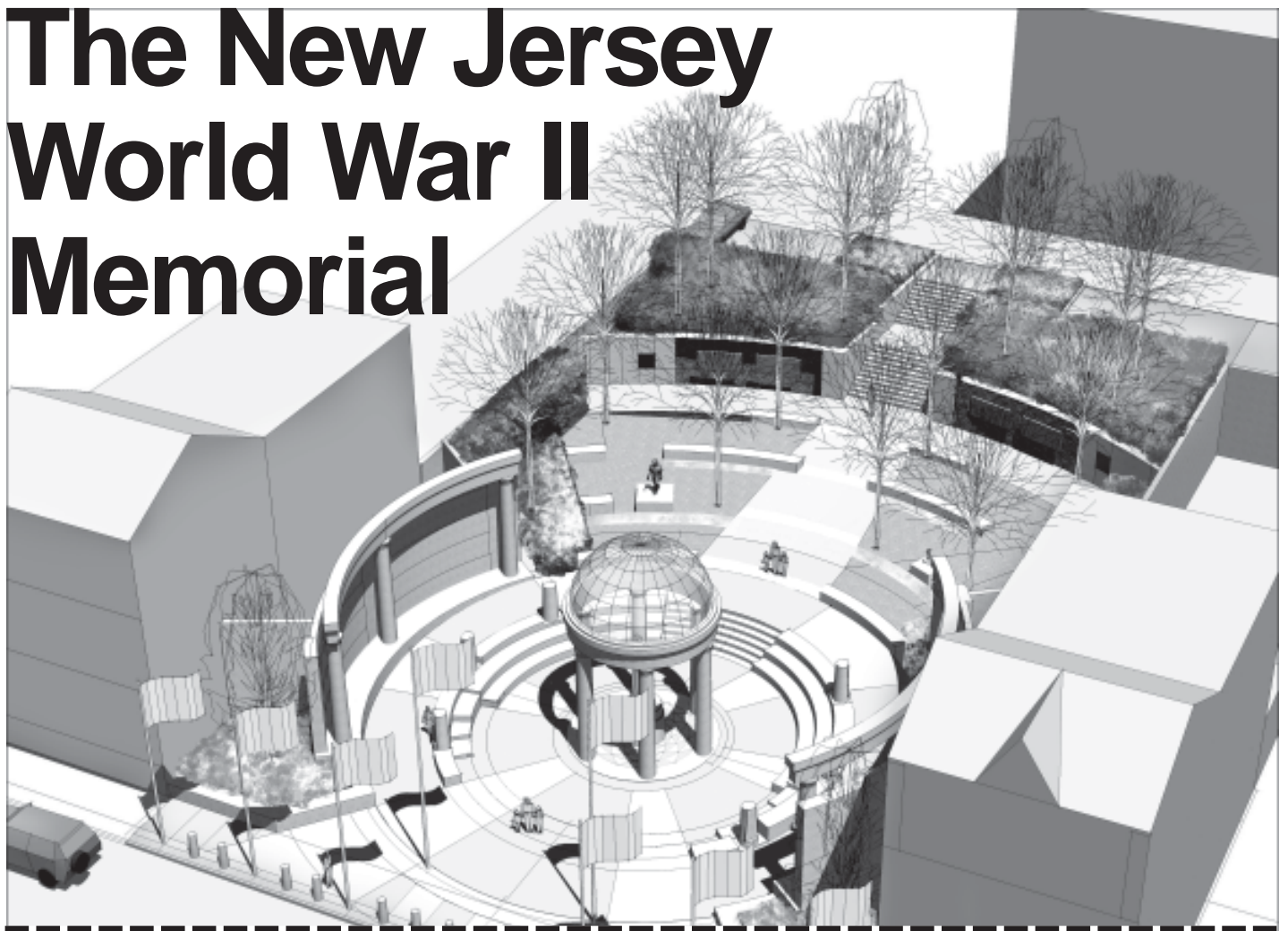

On Oct. 27, the New Jersey Vietnam Veterans' Memorial Foundation celebrated its 10th Anniversary and held its Third Annual Gala, "A Salute to Patriotism" at the Vietnam Era Educational Center and the Robert B. Medicare Prescription Drug Plans

From Veterans Healthcare Services

For the first time in history **Medicare** will be offering **prescription drug coverage** beginning **Jan. 1, 2006**.

Are you eligible? If you are currently receiving **Medicare**, then the answer is **Yes**, regardless of your income.

Who will provide your medication? In New Jersey, a significant number of companies have been authorized by the federal government to offer **Medicare Part D Prescription Drug Plans (PDP)** to New Jersey's Medicare recipients. Each PDP charges a different monthly premium and offers different drug coverage.

Who decides on your PDP? *Each* Medicare recipient must make their **own** decision as to which PDP they will choose. **You** must choose a PDP based on the medications you are taking daily.

How will you know which PDP to choose? You may ask your primary healthcare provider (Medical Doctor) and /or your local pharmacist or you may contact the **State Health Insurance Assistance Program (SHIP)** office in your County and discuss the various PDPs with them in order to make your decision. One note however, your local pharmacist can assist but, by law, cannot recommend a PDP.

When do you have to make a decision on which PDP to choose? Beginning on **15 November 2005**,

you may sign-up for a Medicare D-PDP. **You** and your family, your doctor or your SHIP representative can look at all the different PDPs and pick the one that is best for you. **You** must ensure that the PDP you choose covers the medications/ drugs you take each day. Additional assistance may be obtained from the Social Security Administration and/or the state Medicaid office.

Do I have to sign-up for this program? The Medicare D-PDP in a **voluntary** program. However, if you **do not** choose and sign up for a PDP by **May 15, 2006**, and then wish to enter the program, you will have to pay a substantial penalty for your prescriptions every month for the rest of your life. The benefits package (PDP) program will be activated on **Jan. 1, 2006**.

VA Announces "Fulfilling The Commitment" Initiative

Last week, Department of Veterans Affairs Secretary R. James Nicholson announced the "Fulfilling the Commitment — Coming Home to Work" initiative at a three-day VA conference developed to assist veterans in their transition from military service to civilian life.

"All Americans can be grateful for the service and sacrifice of the men and women of our armed forces," said Nicholson. "The VA is committed to assisting these young heroes in the transition from military life to the civilian workforce through a wide-ranging array of pro-

grams. It just makes good common sense to hire these highly trained, disciplined young people, who volunteered, served and are now honorably discharged."

The Initiative is a comprehensive intergovernmental and public-private alliance that will assure separating Operation Iraqi Freedom and Operation Enduring Freedom veterans that when they return home from their service in the war on terrorism, they will have employment opportunities.

According to Bureau of Labor Statistics, during the first three-

quarters of 2005, nearly 15 percent of veterans 20-24 years old were unemployed — almost three times the national rate.

"These young men and women who protect our way of life need to know that they will have the opportunity to work and take care of their families once they are discharged from military service," said Nicholson.

VA employs nearly 20,000 disabled veterans in its workforce of 237,000, making it one of the nation's largest employers of disabled veterans.

Veterans Day At The N.J. Vietnam Veterans' Memorial

On the 11th hour of the 11th day of the 11th month, the New Jersey Vietnam Veterans' Memorial Foundation was host to a Veterans Day ceremony at the New Jersey Vietnam Veterans' Memorial in Holmdel.

Approximately 400 people attended the commemorative event, which was held in the Memorial's courtyard, surrounded by the circular, black granite wall bearing the names of 1,557 New Jerseyans whose lives were lost in the Vietnam War.

The Keynote Speaker was retired Maj. Gen. Joseph T. Anderson, Marine Corps, Associate Director of the Smithsonian National Air and Space Museum – Steven F. Udvar-Hazy Center. Maj. Gen. Anderson, a 1968 graduate of the U.S. Naval Academy, is a Vietnam veteran fighter pilot, whose last assignment was as Commanding General of the First Marine Aircraft Wing. The Smithsonian's Steven F. Udvar-Hazy Center, located in Chantilly, Va, near Washington Dulles International Airport, displays in open hangar settings, 119 aircraft and 142 large space artifacts, along with more than 1,500 smaller objects, and welcomes more than one million visitors a year.

Two New Jersey Vietnam Veterans – Leo P. Staub (USMC) from Manahawkin, who died July 1, 2003, and Andrew L. Toth (USA) from Edison, who died Dec. 23, 2002 – were inducted into the In Memory Program, which honors those who served in Vietnam and returned home but died later as a result of wounds received in Vietnam. As part of the ceremony, family members spoke about their loved one and lit a candle in their memory. Following the ceremony, attendees enjoyed an Open House in the adjacent Vietnam Era

Educational Center, which includes a museum and research library.

The New Jersey Vietnam Veterans' Memorial and the Vietnam Era Educational Center are located on the grounds of the PNC Bank Arts Center, Holmdel, Monmouth County, (Garden State Parkway exit 116). The Memorial and Educational Center are maintained through a partnership between the New Jersey Vietnam Veterans' Memorial Foundation and the New Jersey Department of Military and Veterans Affairs. The Educational Center is open Tuesday through Saturday, 10 a.m. - 4 p.m. Regular admission is free for veterans and active-duty military personnel. Regular adult admission is \$4; student and senior citizen admission is \$2 and children under 10 are admitted free.

Vets Awarded Jubilee Of Liberty Medal

Some 45 veterans of the Normandy invasion were awarded the Jubilee Of Liberty Medal Nov. 11 in Paramus.

Created by the French Government in conjunction with the 50th Anniversary of the D-Day Invasion June 6, 1944, the Medal is presented to veterans of the Allied Forces who participated. Congressman Scott Garrett, 5th District, facilitated the award of this medalion to eligible constituents in a ceremony at Bergen County Community College. Assisting with the ceremony was a color guard comprised of soldiers assigned to the Teaneck Armory.


Guard Supports Vets Day Parade

New Jersey League Of Community Bankers Establishes Trust Fund

The New Jersey League Of Community Bankers, Cranford, has established the New Jersey League Of Community Bankers Education Foundation, Inc. for dependents of service members who lost their lives in Afghanistan and Iraq. The 75 members of the League will support the fund. Scholarship funds will be considered for applicants with a high school or equivalency diploma in pursuit of higher education, including technical or vocational training, and who demonstrate a financial need. Either the dependent or the service member must have a geographical connection to New Jersey. The Foundation is currently in the fundraising stage and anticipates applications will be accepted in 2006. The Fund's trustees have made all information available to the New Jersey Department of Military and Veterans Affairs and are working with federal and state officials in implementing this program. Raymond Hallock, Chairman, New Jersey League Of Community Bankers, said, "The Board has been inspired by the significant work and sacrifices of United States military personnel throughout the world, particularly in Afghanistan and Iraq. With this scholarship fund we will be honored to help dependents of service members who gave their lives."
