## **Course Purpose:**

Provide training on the interactions necessary for effective management of domestic incidents. Exercise the interfaces between all levels of government with the State EOC in alignment with the National Framework

#### **Course Description:**

An Integrated Emergency Management Course (IEMC) was developed to reinforce the understanding of the roles and relationships among Federal, State, Tribal, and local emergency management organizations as well as the private sector and non-governmental agencies. The course emphasizes the concept that the Whole Community needs to be engaged as emergency management stakeholders in order to operate in an integrated, collaborative environment when responding to any incident. This course also strengthens the State's internal Emergency Operations Center staffing capacity in a no-fault training environment so that more personnel with practical experience can staff the EOC during an incident. The more experienced State EMA and Agency personnel assisted during the exercise as controllers in the Simulation Cell. This enables lesser qualified personnel to enhance their learning experience by performing the tasks associated with their position during the functional exercise.

The State NRF IEMC is conducted using each State's Emergency Operations Centers and its existing resources, policies, plans, procedures, communications, and information technology. These tailored exercises are designed in coordination with each State and attempt to replicate the realistic challenges that stimulate the State and Federal decision-making process and introduce long-term solutions to resolve those challenges to benefit a more effective, i.e., integrated and collaborative, response. Each State was able to choose between a three-day course composed of two days of classroom instruction and a one-day response exercise or a four-day course that adds a recovery exercise on the fourth day.

In addition to familiarizing participants with the NRF and NIMS, instructional goals for these courses address key topical areas such as State Hazards, Situational Analysis, Common Operating Picture, the
