### **Program Summary**

This program will provide guidance for interacting with the media and collaborating with the communications office to promote the work of your division on behalf of the Department of Law and Public Safety. The program will include a review of LPS media policies and procedures. It will also address media relations in the course of litigation, the ethics of litigation publicity and compliance with the applicable Rules of Professional Conduct.

## Who Is the Faculty?

**DAG Erik Daab** is the Deputy Chief of the Gangs and Organized Crime Bureau of the Division of Criminal Justice, prosecuting large-scale narcotics and weapons trafficking cases. He previously served in the Appellate Bureau, Corruption Bureau, and as Chief of the Medicaid Fraud Unit in the Division of Criminal Justice. Erik started his career working on death penalty cases for the Tennessee Office of the Attorney General and was the State Witness for the execution of the first inmate executed in Tennessee in forty years.

**Sharon Lauchaire** is the Director of Communications for the Department of Law and Public Safety. She coordinates media and public relations for the Office of the Attorney General and all divisions within the Department and oversees multi-media, social media, publications, and websites.
