### **Program Summary**

The Division of Gaming Enforcement and the Casino Control Commission regulate all aspects of wagering in New Jersey, from the 1978 debut of casino gaming in Atlantic City to the inception of sports wagering in casinos, racetracks and via mobile platforms forty years later.

This program will focus on the history of casino gaming, the structure and distinct roles of its two regulatory agencies, the standards for licensing casinos, service industries, and employees and the protracted effort to authorize sports wagering in New Jersey. It will also cover the operational controls applicable to traditional casino games and sports wagering. The presenters will explain the application process, the hearing process, and permissible activities for casinos and their sports wagering partners.

# Who Is the Faculty?

**AAG Mary Jo Flaherty** is a deputy director of the Division of Gaming Enforcement. She is responsible for casino licensing, financial analyses and reporting, employee licensing, OPRA, EEO within the industry and Division, ethics, and law enforcement agency and gaming authority releases of information. She also handles legislation, regulations, policy issues, and special projects. She previously worked for the Administrative Office of the Courts and served a judicial clerkship. ## **State Employees**

### Non-State Employees or State Employees not Connected to the Garden State Network

Setting up your account through the portal is a two-step process, the details of which are set forth in the next two paragraphs.

Once you receive the portal authorization code you will be prompted to go to the My New Jersey portal at <a href="http://www.state.nj.us/">http://www.state.nj.us/</a> and create a portal account. Once your portal account is created you are prompted to enter your authorization code. This is Step 1 of the process, which you need only do once.

If you have already been issued an authorization code in the past you do not need to request another one. You can log into your account on the Garden State Network at http://www.state.nj.us and under the heading NJ L&PS Applications you will see the Attorney General's Advocacy Institute's Registration System. Click on that and log into your account on our system.

Upon setting up your portal account, you need to set up your AGAI Course Registration System

account. This is Step 2. To do so, log on to the My New Jersey Portal <a href="http://www.state.nj.us/">http://www.state.nj.us/</a>.
