Program Summary

This presentation will explore several topics related to insurance company special investigation units and civil and criminal insurance fraud investigations. The presenter will explore the New Jersey Bad Faith Bill, including its status and how or if it will affect insurance companies in both civil and criminal investigations if enacted. The discussion will include the different aspects in which this proposed bill will impact the insurance industry, including how a carrier investigates fraud and the ultimate effect on criminal cases. The presenter will provide examples of how this law has affected states that have enacted it and will review top trends from across the nation so New Jersey attorneys and investigators will know what to expect both civilly and criminally if the bill becomes law.
