COUNT ONE

(Endangering the Welfare of a Child)

(Distribution of Child Pornography - Second Degree)

WALTER EDWARD WHETZEL, JR.

between on or about April 12, 2004 and on or about April 13, 2004, in the City of Trenton, in the County of Mercer and/or in the State of Maryland, elsewhere, and within the jurisdiction of this Court, did knowingly sell, procure, manufacture, give, provide, lend, trade, mail, deliver, transfer, publish, distribute, circulate, disseminate, present, exhibit, advertise, offer or agree to offer, through any means, including the Internet, a photograph(s), computer program(s) or file(s), or any other reproduction or reconstruction, which depicts a child engaging in a prohibited sexual act or in the simulation of such an act as defined by

N.J.S.A. 2C:24-4b(1), to "nj_kris14boi" in New Jersey, contrary to the provisions of N.J.S.A. 2C:24-4b(5)(a), and against the peace of this State, the government and dignity of the same.

COUNT TWO

(Attempted Endangering the Welfare of a Child - Second Degree)
WALTER EDWARD WHETZEL, JR.

between on or about April 7, 2004 and on or about July 12, 2004, in the City of Trenton, in the County of Mercer and/or in the State of Maryland, elsewhere, and within the jurisdiction of this Court, did purposely attempt to cause a child, namely, "nj_kris14boi" in New Jersey to engage in a prohibited sexual act as defined in N.J.S.A. 2C:24-4b(1) or in the simulation of such an act, when WALTER EDWARD WHETZEL, JR., knew, had reason to know and/or intended that the prohibited act would be photographed, contrary to the provisions of N.J.S.A. 2C:5-1 and N.J.S.A. 2C:24-4b(3), and against the peace of this State, the government and dignity of the same.

COUNT THREE

(Attempted Endangering the Welfare of a Child - Second Degree)

(Attempted Endangering the Welfare of a Child - Third Degree)
WALTER EDWARD WHETZEL, JR.

between on or about April 7, 2004 and on or about July 12, 2004, in the City of Trenton, in the County of Mercer and/or in the State of Maryland, elsewhere, and within the jurisdiction of this Court, did purposely attempt to engage in sexual conduct which would impair or debauch the morals of "nj_kris14boi" in New Jersey, contrary to the provisions of N.J.S.A. 2C:5-1 and N.J.S.A. 2C:24-4a, and against the peace of this State, the government and dignity of the same.
