ATLANTIC CITY— Casinos reported \$296.3 million in casino win in September, a decrease of 11.6 percent over the same month a year ago.

Results reported to the New Jersey Casino Control Commission Tuesday show that the 11 casinos won \$209 million at the slot machines and another \$87.4 million at table games in September. Slot revenue fell 9.9 percent while table game revenues decreased by 15.6 percent. After adjustments and a deduction for promotional gaming credits, casinos paid \$20.8 million on taxable gross revenue of \$259.6 million in September. That money, 8 percent of taxable gross revenue, goes into the Casino Revenue Fund, which pays for programs that benefit qualifying senior citizens and people with disabilities. In addition, the casinos incurred another \$3.7 million in reinvestment obligations. They are required to reinvest 1.25 percent of gross revenues in projects approved by the Casino Reinvestment Development Authority.

For the first nine months of the year, casinos won \$2.8 billion, down 8.7 percent from the same period in 2009. Revenue from slot machines was down 8.5 percent and revenue from table games was down 9.3 percent for the nine months. Taxable gross revenue fell 10.8 percent to \$2.6 billion.

Win, or casino revenue, is the net amount of money won by casinos. It is not profit.
