## **DGE Announces April 2013 Casino Win Results**

### ATLANTIC CITY —

Based upon filings with the Division of Gaming Enforcement, total casino win was \$228.5 million in April 2013 compared to \$259.9 million last April. Table game win was \$66.8 million, reflecting a change of 6.0% compared to the prior period. Slot machine win was \$161.7 million, reflecting a variance of 14.4% due in part to the impact of a \$5.5 million, or 15.7%, reduction in promotional gaming credits wagered compared to the same period last year.

Casinos incurred \$16.5 million in taxes on their gross revenues in April. That money, 8 percent of taxable gross revenue, goes into the Casino Revenue Fund, which pays for programs that benefit qualifying senior citizens and people with disabilities. In addition, the casino industry incurred \$2.9 million in reinvestment obligations based on their gross revenues for the month. Casinos are required to reinvest 1.25 percent of gross revenues in projects approved by the Casino Reinvestment Development Authority.

For the first four months of the year, casinos won \$884.6 million reflecting a change of 12.1% from the same period last year.

Win reflects the net amount of money won by casinos. It is not profit.
