Some of CPA's efforts were related to the topic of the authorization of Internet gaming (which Borgata conservatively estimates were no more than 5% of CPA's efforts on behalf of Borgata) and many were related to other interests of Borgata. Since Borgata retained CPA on a monthly retainer basis, CPA was not required to identify the matters on which it worked or allocate the time it spent to any particular matter. Accordingly, Borgata has herein reported all of its lobbying and consulting fees it paid to CPA during the above time period which amounts will therefore capture fees related to Internet gaming as well as all other matters CPA performed on Borgata's behalf.</p>


