INTERNET GAMING Companies Issued a Transactional Waiver

Last Update: February 3, 2014

Pursuant to N.J.S.A. 5:12-92a(1) of the New Jersey Casino Control Act, Casino Service Industry Enterprise's ("CSIE") are those entities which supply goods and services directly related to the operation of the casino such as gaming equipment, simulcast wagering equipment, or slot machine distributors. Providers of Internet gaming systems and services to the casinos are also included in this category.

Under the Act, the Division has the authority to issue transactional waivers to Internet gaming companies that have submitted a completed CSIE application and have been subject to preliminary investigation. The following companies have been issued a transactional waiver and are authorized to engage in Internet gaming activities. A plenary license will be issued after full investigation is completed.
